

Enclosed are ADMINISTRATIVELY CORRECTED pages to the initial Title V operation permit, 1050003-004-AV for the operation of the Charles Larsen Memorial Power Plant located at 2002 East U.S. Highway 92, Lakeland, Polk County. This correction is issued pursuant to Rule 62-210.360, Florida Administrative Code and Chapter 403, Florida Statutes (F.S.). This change is made at the applicant's request, dated 10/24/01, to add a permitting note to various emissions units addressing the need to record heat input on a continuing basis. This corrective action does not alter the effective dates of the existing permit.

Any party to this order (permit) has the right to seek judicial review of the permit pursuant to Section 120.68, F.S., by the filing of a Notice of Appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Department in the Legal Office; and, by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The Notice of Appeal must be filed within 30 (thirty) days from the date this Notice is filed with the Clerk of the Department.



The following permitting note shall be added after Specific Conditions **A.1.**, **B.1.**, **C.1.**, and, **D.1.**:

{Permitting note: The heat input limitations have been placed in each permit to identify the capacity of each unit for the purposes of confirming that emissions testing is conducted within 90 to 100 percent of the unit's rated capacity (or to limit future operation to 110 percent of the test load), to establish appropriate emission limits and to aid in determining future rule applicability. Regular record keeping is not required for heat input. Instead the owner or operator is expected to determine heat input whenever emission testing is required, to demonstrate at what percentage of the rated capacity that the unit was tested. Rule 62-297.310(5), F.A.C., included in the permit, requires measurement of the process variables for emission tests. Such heat input determination may be based on measurements of fuel consumption by various methods including but not limited to fuel flow metering or tank drop measurements, using the heat value of the fuel determined by the fuel vendor or the owner or operator, to calculate average hourly heat input during the test.}

Dear Mr. Hulbert:

The Department has received a request from Ms. Farzie Shelton on September 24, 2001 for what were, at the time, considered Administrative Permit Corrections to the Title V Permits for the Larsen and McIntosh Power Plants. On October 17, 2001, we received another electronic mail message request from Ms. Shelton amending the requested language of the previously proposed permitting note. She also requested that these changes be incorporated into the permit condition rather than be addressed as a permitting note. The Department is unclear if Lakeland Electric is requesting an Administrative Permit Correction (in the form of a permitting note which clarifies, but does not change a permit condition) or is requesting revisions to the Title V permits (a revision is required to change a permit condition). If Lakeland Electric is requesting revisions to the permits, appropriate permit applications must be submitted.

Permit applicants are advised that Rule 62-4.055(1), F.A.C. now requires applicants to respond to requests for information within 90 days. If you have any questions regarding this matter, please call Edward J. Svec at 850/921-8985.
