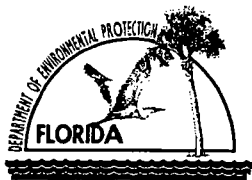
Lakeland Electric (Lakeland) is updating the Responsible Official Notification information that the Florida Department of Environmental Protection has on file for the C.D. McIntosh, Jr. Power Plant (1050004-029-AV), the Charles Larsen Memorial Power Plant (1050003-015-AV), and the Winston Peaking Station (1050352-005-AV). This notification is in compliance with Rules 62-210.200 and 62-213, F.A.C. The revision includes two (2) updated Additional Responsible Officials for all three facilities. The new Additional Responsible Officials for all three facilities are Mr. Ronald Kremann and Mr. Ken Riddle, both effective November 7, 2011. Messrs. Kremann and Riddle have the necessary authority to carry out the duties and responsibilities of the Title V Program under the Clean Air Act on behalf of Lakeland Electric. The Primary Responsible Official for all three facilities will remain Mr. Tony Candales, and Mr. Steve Marshall, who was previously certified as an Additional Responsible Official, will also remain in such capacity with Lakeland Electric.


