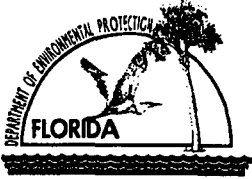
Lakeland Electric (Lakeland) is updating the Responsible Official Notification information that the Florida Department of Environmental Protection has on file for the C.D. McIntosh, Jr. Power Plant (1050004-023-AV), the Charles Larsen Memorial Power Plant (1050003-015-AV), and the Winston Peaking Station (1050352-002-AV). This notification is in compliance with Rules 62-210.200 and 62-213, F.A.C. The revision includes an updated Primary Responsible Official for all three facilities. The new Primary Responsible Official for all three facilities will be Mr. Thomas J. Trickey, effective December 7, 2009. Mr. Trickey has the necessary authority to carry out the duties and responsibilities of the Title V Program under the Clean Air Act on behalf of Lakeland Electric. The Additional Responsible Official for all three facilities will remain Mr. Tony Candales.
