REQUEST FOR SECOND EXTENSION OF TIME

By and through undersigned counsel, Lakeland Electric (Lakeland) hereby requests, pursuant to Florida Administrative Code Rule 62-110.106(4), a second extension of time, to and including September 2, 2002, in which to file a Petition for Administrative Proceedings in the above-styled matter. As good cause for granting this request, Lakeland states the following:


1. On June 3, 2002, Lakeland received from the Department of Environmental Protection (Department) a "Draft PSD Permit Modification" (DEP File No. PSD-FL-245) related to startup emissions on the McIntosh Unit 5 Combined Cycle Unit located in Polk County, Florida.
2. The Draft PSD Permit Modification contains several provisions that warrant clarification, correction, or revision.
3. Lakeland submitted a request for extension of time until July 17, 2002 to file a petition for administrative hearing, and this request was granted by the Department on June 28, 2002.
4. Counsel for Lakeland has contacted Doug Beason of the Department's Office of General Counsel regarding this request for an extension of time until September 2, 2002, and he has no objection.

5. This request is filed simply as a protective measure to avoid waiver of Lakeland's right to challenge certain conditions contained in the proposed permit. Grant of this request will not prejudice either party, but will further their mutual interest and likely avoid the need to file a petition and proceed to a formal administrative hearing.

WHEREFORE, Lakeland respectfully requests that the time for filing of a Petition for Administrative Proceedings in regard to the Department's Draft PSD Permit Modification for Permit No. PSD-FL-245 be formally extended to and including September 2, 2002. If the Department denies this Request, Lakeland requests the opportunity to file a Petition for Administrative Proceedings within 10 days of such denial.
