Dear Mr. Vo:

On July 7, 2005, the Department issued a Draft Title V air permit renewal which included 'Statement of Basis', 'DRAFT Permit', 'Written Notice of Intent to Issue Title V Air Operation Permit', and 'Public Notice of Intent to Issue Title V Air Operation Permit (Public Notice)'. The Title V air permit renewal was for the operation of the Fort Meade Plant located at 3225 SR 630 West, Fort Meade, Polk County. An extension of time to file a petition for administrative hearing was granted until September 19, 2005, but an administrative hearing was not requested.

On September 21, 2005, your consultant Koogler & Associates submitted a letter requesting the Department to issue a revised draft permit. The Department will not issue a revised draft. Furthermore, the Department will issue a denial of the Title V air permit renewal unless the Public Notice is published in the legal advertisement section of a newspaper of general circulation in the area affected by the project by **November 15, 2005**. You are required to submit a notarized statement from the newspaper to the Department within 7 days of publication.
