The Department received your October 20 letter requesting two year extensions of the subject permits due to a market downturn in the phosphate industry.

Eighteen month extensions can be granted without re-evaluating the BACT analysis, however, for two year extensions, a condition would have to be added requiring re-evaluation of the BACT analysis before construction begins (F.A.C. Rule 17-212.410(2)). If you want us to process the two year extension with BACT re-evaluation required, please advise.
