This submittal is made pursuant to Specific Condition III. 23. of the above-referenced construction permit.

01 Plant Construction, Emission Unit 002

- 9/7/02 The plant was shut down for turnaround.
 - 48,000 liters of Monsanto SCX-2000 Cesium Catalyst was installed in the 4th Pass.
 - > A new Monsanto IPA Tower (Alloy) was installed.
- 9/23/02 The plant returned to service.
- 9/29/02 The plant was taken down to identify Converter and Hot-Pass Heat Exchanger problems and make needed repairs.
 - > A hole in 1 grid in the 4th Pass was identified and repaired.
 - > A dropped grid in the 2nd Pass was located and repaired.
 - > Tubes were found to be leaking in the Hot-Pass Heat Exchanger.
- 10/3/02 The plant returned to service.

- 12/7/02 The plant was shut down to identify additional problems in the Converter and/or Hot-Pass Heat Exchanger and make needed repairs.
 - > Leaking tubes in the Hot-Pass Heat Exchanger were repaired.
 - > No repairs to the Converter were needed.
- 12/12/02 The plant returned to service.

02 Plant Construction, Emission Unit 003

There is no construction activity planned for this unit.

03 Plant Construction, Emission Unit 004

- 34 1/25/03 This plant will be shut down for turnaround.
 - > A Monsanto SCX-2000 Cesium Catalyst will be installed in the 4th Pass.
