After our meeting with Mike C. this morning on the heat input issue and discussions of how to proceed and what legal actions are pending out there, I thought this would be helpful for you and all of our permittees.

Priority #1: demonstrating that the heat input issue is resolved

The renewals that are affected by this issue [according to my records] follow. For those in which extensions of time have been filed, we need to email a draft proposed permit to their attorney and a cc. to the responsible official. **IF THE COMMENT PERIOD HASN'T EXPIRED YET, WE SHOULD NOTE THAT, BARRING ANY COMMENTS, HERE IS WHAT WE INTEND TO ISSUE.** Once they've reviewed and concurred and the comment period has passed, their attorney will withdraw the extensions of time [or notify us they will not be petitioning]. Mike requested this be done by Tuesday afternoon for as many as possible. I suggest we start with those permits where heat input is the only outstanding issue.

**SECOND REQUEST FOR ENLARGEMENT OF TIME**

By and through undersigned counsel, Progress Energy Florida, Inc. (Progress) hereby requests, pursuant to Florida Administrative Code Rule 62-110.106(4), an enlargement of time, to and including November 15, 2004, in which to file a Petition for Administrative Proceedings in the above-styled matter. As good cause for granting this request, Progress states the following:

1. On or about August 16, 2004, Progress received from the Department of Environmental Protection (Department) an "Intent to Issue Title V Air Operation Permit" (Draft Permit No. 1050223-012-AV) for the Progress Tiger Bay facility, located in Polk County, Florida. Progress subsequently filed a Request for Enlargement of Time until November 26, 2004, to preserve its right to file a Petition for Administrative Proceeding on this permit.
2. By the letter dated September 2, 2004, the Department issued an "Intent to Issue an Air Construction Permit and a Title V Air Operation Permit" for the Tiger Bay facility.



3. The Department's cover letter to the permit states that the September 2, 2004, "Intent to Issue an Air Construction Permit and a Title V Air Operation Permit" is replacing the initial Draft Title V permit. In reliance on this representation, Progress hereby files this Request for Enlargement of Time on the Draft permits, and understands that no further extensions of time are needed to preserve its rights in relation to the initial Title V permit because it has been effectively withdrawn and replaced. Nonetheless, insofar as the initial Draft Title V permit may be determined to still be in effect, Progress respectfully requests that this Request for Enlargement of Time apply to both the initial and the replacement Draft Title V permits.

4. Based on Progress' review, the Draft permit and associated documents contain several provisions that warrant clarification or correction.


5. The Department granted Progress' first Request for Enlargement of Time, allowing until October 15, 2004, to file a petition in this matter.

6. Progress is now requesting until November 15, 2004, in order to resolve remaining issues before the Department's intended deadline to send all Title V renewals to the Environmental Protection Agency as proposed permits.

7. This second request is filed simply as a protective measure to avoid waiver of Progress' right to challenge certain conditions contained in the Draft Title V permit. Grant of this request will not prejudice either party, but will further their mutual interest and hopefully avoid the need to file a petition and proceed to a formal administrative hearing.

WHEREFORE, Progress respectfully requests that the time for filing of a Petition for Administrative Proceedings in regard to the Department's Intent to Issue Title V Air Operation Permit for Draft Permit No. 1050223-012-AV be formally extended to and including November 15, 2004.



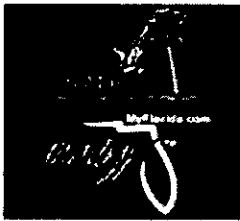

On or about August 16, 2004, Progress received from the Department of Environmental Protection (Department) an "Intent to Issue Title V Air Operation Permit" (Draft Permit No. 1050223-012-AV) for the Progress Tiger Bay facility, located in Polk County, Florida. Progress subsequently filed a Request for Enlargement of Time until November 26, 2004, to preserve its right to file a Petition for Administrative Proceeding on this permit.

2. By the letter dated September 2, 2004, the Department issued an "Intent to Issue an Air Construction Permit and a Title V Air Operation Permit" for the Tiger Bay facility.

3. The Department's cover letter to the permit states that the September 2, 2004, "Intent to Issue an Air Construction Permit and a Title V Air Operation Permit" is replacing the initial Draft Title V permit. In reliance on this representation, Progress hereby files this Request for Enlargement of Time on the Draft permits, and understands that no further extensions of time are needed to


preserve its rights in relation to the initial Title V permit because it has been effectively withdrawn and replaced. Nonetheless, insofar as the initial Draft Title V permit may be determined to still be in effect, Progress respectfully requests that this Request for Enlargement of Time apply to both the initial and the replacement Draft Title V permits.

4. Based on Progress' review, the Draft permit and associated documents contain several provisions that warrant clarification or correction.

5. This request is filed simply as a protective measure to avoid waiver of Progress' right to challenge certain conditions contained in the Draft Title V permit. Grant of this request will not prejudice either party, but will further their mutual interest and hopefully avoid the need to file a petition and proceed to a formal administrative hearing.

WHEREFORE, Progress respectfully requests that the time for filing of a Petition for Administrative Proceedings in regard to the Department's Intent to Issue Title V Air Operation Permit for Draft Permit No. 1050223-012-AV be formally extended to and including November 26, 2004.


