Thank you for your recent submission of a Title V Air Operation Permit Renewal Application, and Application for a Minor Modification (amendment to permit PSD-FL-206) for the referenced plant. However, we must deem your applications *incomplete*, due to the omission of engineering computations evaluating the increase in potential emissions for all pollutants reflecting the request for an increase in the maximum heat input rate for the two combustion turbines from 368.3 mmBtu/hr to 377 mmBtu/hr (as noted in your attachment OC-FI-006).

Also, please check if there are any changes to the Designated Representative for the facility, and submit an updated Certificate of Representation if necessary.
