Dear Mr. Frost:

On May 28, 2009, the Department received a response to an incompleteness letter regarding a modification request for the No. 4 combination boiler. Based on our review of the proposed project, we have determined that the following additional information is needed in order to continue processing this application package. Please provide all assumptions, calculations, and reference material(s), that are used or reflected in any of your responses to the following issues:

1. There have been several air construction projects issued by the Department that are within the contemporaneous period of this project. If there were any pollutant increases or decreases, then they should be accounted for in the netting table.
2. Regarding the exemption granted for the HVLC sources for TRS emissions, my notes of the March 24, 2009, indicate that I wanted the exemption to be included on the netting table, but showing no contribution of pollutant emissions. Therefore, please include the exemption action in the netting table.
3. Please provide us with an update of the progress toward the elimination of No. 6 fuel oil and the conversion to 100% natural gas for the No. 4 combination boiler, since the creditable SO₂ reductions depend on this action.
