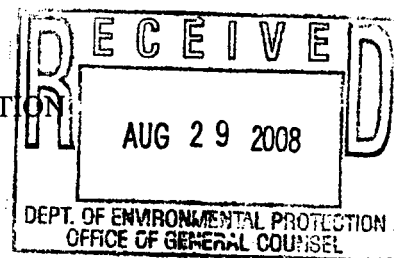

REQUEST FOR ENLARGEMENT OF TIME

By and through undersigned counsel, Florida Power and Light Company, ("FPL") hereby requests, pursuant to Florida Administrative Code Rule 62-110.106(4), an enlargement of time, to and including October 29, 2008, in which to file a Petition for Administrative Proceedings in the above-styled matter. As good cause for granting this request, FPL states the following:


1. On or about August 15, 2008, FPL received from the Department of Environmental Protection ("Department") an "Intent to Issue Air Permit" and accompanying "Draft Permit" (No. 1070014-006-AV), which is a renewal of the existing Title V Permit for the Putnam Power Plant, which is located approximately at 392 US Highway 17 South, East Palatka, Florida 32131, Putnam County, Florida.
2. Based on FPL's initial review, the Draft Permit and associated documents contain several provisions that warrant clarification or corrections.
3. FPL is preparing written comments and will be discussing with the Department possible resolutions to the issues needing clarification or correction.

4. This request is filed simply as a protective measure to avoid waiver of FPL's right to challenge certain conditions contained in the Draft Permit, in the event resolution cannot be reached. Grant of this request will not prejudice either party, but will further their mutual interest and hopefully avoid the need to file a Petition and proceed to a formal administrative hearing.

WHEREFORE, FPL, Inc. respectfully requests that the time for filing of a Petition for Administrative Proceedings in regard to the Department's Intent to Issue Air Project No. 1070014-006-AV be formally extended to and including October 29, 2008.


