Pursuant to Chapter 119, Florida Statutes, Earthjustice requests that the following documents be produced for inspection and copying on **July 27, 2009**. To assist you in locating these records, please note that they relate to the impact analysis and emission rate calculations for the Seminole Draft Permit (Notice of Intent issued 6/12/09) and specifically include all previous analysis of Unit 3 relied upon, including documents prepared for Permit No. PSD-FL-375 or for Project No. 1070025-005-AC. **E-mail correspondence, excel spreadsheets and other data files may be provided electronically on CDs. Email should be in Microsoft Outlook format. Worksheets should be provided as native excel spreadsheets (.xls file extension).**

INSTRUCTIONS

1. The term "documents" is as defined in Rule 1.350(a), Florida Rules of Civil Procedure, and includes all documents in the possession, custody or control of FDEP (including, without limitation, documents within the possession, custody or control of your attorneys, agents, or contractors that you have a legal right to obtain, copy, or have access to, wherever located). **It specifically includes all e-mail correspondence between FDEP, and/or any other person (as defined herein.)**

2. The terms "you," "yours," "Florida Department of Environmental Protection," or "FDEP" refer to the entity towards whom this public records request is directed and includes all employees, agents, attorneys, contractors, and representatives of said entity.

3. The term "related to" as used herein shall mean constituting, containing, concerning, indicating, alluding to, responding to, connected with, commenting on, in respect to, discussing, describing, reflecting, analyzing, projecting, embodying, identifying, stating, dealing with, or in any way pertaining to.

4. "Person" shall mean the plural as well as the singular and includes any natural person, and any firm, agency, company, corporation, association, partnership, the government, or other form of legal entity.

5. A privilege log is requested if any documents are withheld on the basis of a claim of privilege.


RECORDS REQUEST

1. All emission rate calculations and tables submitted by the Applicant or prepared by FDEP for the proposed Seminole 3 facility. Please provide these calculations and tables in the form of native excel spreadsheets (.xls file extension).
2. All Class I impact analyses, whether prepared by the applicant or FDEP, specifically including:
 - All CALPUFF input and output files.
 - All CALPOST input and output files.
 - All meteorological data for the Class I modeling for the proposed Seminole Unit 3 facility, including all CALMET input and output files used to prepare the CALPUFF Class I impact analyses.
 - All other files necessary to prepare the CALMET modeling, including any TERREL, CTGCOMP, CTGPROC, and MAKEGEO inputs and outputs used to create the inputs to CALMET.
 - All air quality and other non-meteorological data used in the CALPUFF Class I impact analyses.
 - All documentation, modeling protocols, memos, meeting notes, emails, etc., relating to the Class I modeling analyses.
3. All electronic files necessary to recreate the Seminole Unit 3 Class I impact analyses.
4. All Class II impact analyses, whether prepared by the applicant or FDEP, specifically including:

- All AERMOD input and output files, including surface and upper air meteorological data.
- All AERMET input and output files, including any land use/land cover files used in preparing the meteorological data files.
- All AERMAP input and output files, including any DEM or other terrain elevation files.
- All documentation, modeling protocols, memos, meeting notes, emails, etc., relating to the Class II modeling analyses.
