SECOND REQUEST FOR ENLARGEMENT OF TIME

By and through undersigned counsel, Seminole Electric Cooperative, Inc. ("Seminole") hereby requests, pursuant to Florida Administrative Code Rule 62-110.106(4), an enlargement of time, to and including January 15, 2010, in which to file a Petition for Administrative Proceedings in the above-styled matter. As good cause for granting this request, Seminole states the following:

- 1. On or about October 22, 2009, Seminole received from the Department of Environmental Protection ("Department") an "Intent to Issue Title V Air Operation Permit Renewal" (Draft Renewal Permit No. 1070025-13-AV), for the Seminole Generating Station, located in Putnam County, Florida. Along with the Intent to Issue, Seminole received a Draft Title V permit renewal and "Public Notice of Intent to Issue Title V Air Operation Permit Renewal." The above mentioned Draft Permit Renewal is a renewal of Title V Air Operation Permit No, 1070025-002-AV.
- 2. On November 4, 2009, Seminole file a Request for Enlargement of Time, which DEP granted until November 30, 2009.

3. Based on Seminole's initial review, the Draft Permit Renewal and associated documents contain several provisions that warrant clarification or corrections. On November 24, 2009, Seminole filed written comments concerning the Draft/Proposed Renewal, and is awaiting DEP's response.

4. This request is filed simply as a protective measure to avoid waiver of Seminole's right to challenge certain conditions contained in the Draft Title V Permit Renewal. Grant of this request will not prejudice either party, but will further their mutual interest and hopefully avoid the need to file a Petition and proceed to a formal administrative hearing. In the event all issues are resolved prior to January 15, 2010, Seminole will withdraw this Request.

5. If the Department denies this request, Seminole requests the opportunity to file a Petition for Administrative Proceeding within 10 days of such denial.

WHEREFORE, Seminole respectfully requests that the time for filing of a Petition for Administrative Proceedings in regard to the Department's Intent to Issue Title V Air Operation Permit for Draft Permit No. 1070025-13-AV be formally extended to and including January 15, 2010.
