Jeff: Our Project Engineer on this project is confirming the ventilation design specifics with Black&Veatch and I'll get back to you, hopefully this afternoon to verify. The system includes a fan to pull the displaced air from the truck being loaded and send that air back into the ash silo that is equipped with a filter. Mike

Mike,

This got forwarded to me. Generally, we give AC permits to install the baghouses on the silo and possibly the "telescoping spout with ventilation system to capture fugitive PM". These sound like control devices. Rule 62-210.300(1), F.A.C. requires an AC permit for the addition of air pollution controls. The exemption you mention is based on potential emissions, which is calculated without controls unless authorized by a federally enforceable permit. (We are working on a rule change that may specifically exempt small baghouses, but it's not ready yet.)

It's possible that we could issue a case-by-case exemption in accordance with Rule 62-4.040, F.A.C.

What is the ventilation system that captures fugitive PM from the telescoping spout?
