Section 7661d(b)(2), any person may petition the Administrator of the EPA within 60 (sixty) days of the expiration of the Administrator's 45 (forty-five) day review period as established at 42 U.S.C. Section 7661d(b)(1), to object to issuance of any permit renewal.

Any petition shall be based only on objections to the permit renewal that were raised with reasonable specificity during the 30 (thirty) day public comment period provided in this notice, unless the petitioner demonstrates to the Administrator of the EPA that it was impracticable to raise such objections within the comment period or unless the grounds for such objection arose after the comment period.

Filing of a petition with the Administrator of the EPA does not stay the effective date of any permit properly issued pursuant to the provisions of Chapter 62-213, F.A.C. Petitions filed with the Administrator of EPA must meet the requirements of 42 U.S.C. The Department of Environmental Protection (permitting authority) gives notice of its Intent to Issue a Title V Air Permit Renewal to Ft. Pierce Utilities Authority for the H. D. King Power Plant located at 311 North Indian River Drive, Ft. Pierce, St. Lucie County. This is a renewal to Title V Air Operation Permit No. 1110003-003-AV. The applicant's name and address are: Ft. Pierce Utilities Authority, Thomas W. Richards, Director of Operations, P. O. 8ox 3191, Ft. Pierce, Florida 34948.

The permitting authority will issue the PROPOSED Permit, and subsequent FINAL Permit, in accordance with the con-ditions of the DRAFT Permit unless a response received in accordance with the following procedures results in a different decision or significant change of terms or conditions.

The permitting authority will accept written comments concerning the proposed DRAFT Permit issuance action for c period of 30 (thirty) days from the date of publication of this Notice. Written comments should be provided to the Department's Bureau of Air Regulation, 2600 Blair Stone Road, Mail Station #5505, Tallahassee, Florida 32399 2400. Any written comments filed shall be made available for public inspection. If written comments received result in a significant change in this DRAFT Permit, the permitting authority shall issue a Revised DRAFT Permit and require, i applicable, another Public Notice.

A person whose substantial interests are affected by th proposed permitting decision may petition for an administrative hearing in accordance with Sections 120.569 an 120.57, Florida Statutes (F.S.). The petition must contain the information set forth below and must be filed (received in the Office of General Counsel of the Department of Environmental Protection, 3900 Commonwealth Boulevar. Mail Station #35, Tallahassee, Florida 32399-3000 (Telephone: 850/488-9730; Fax: 850/487-4938). Petitior filed by any persons other than those entitled to write notice under Section 120.60(3), F.S., must be filed with fourteen days of publication of the public notice or with fourteen days of receipt of the notice of intent, whichevoccurs first. Under Section 120.60(3), F.S., however, or person who asked the permitting authority for notice agency action may file a petition within fourteen days a receipt of that notice, regardless of the date of publication A petitioner shall mail a copy of the petition to the appi cant at the address indicated above, at the time of filing The failure of any person to file a petition within the appcable time period shall constitute a waiver of that person right to request an administrative determination (hearing under Sections 120.569 and 120.57, F.S., or to intervene this proceeding and participate as a party to it. Ar subsequent intervention will be only at the approval of the presiding officer upon the filing of a motion in compliant with Rule 28-106.205, Florida Administrative Cor

A petition that disputes the material facts on which the ermitting authority's action is based must contain the fo lowing information:

(a) The name and address of each agency affected a each agency's file or identification number, if known; (b) The name, address and telephone number of the p tioner; name address and telephone number of the petitio tioner; name address and telephone number of the petitic er's representative, if any, which shall be the address of service purposes during the course of the proceeding; or an explanation of how petitioner's substantial rights will affected by the agency determination; (c) A statement of how and when the petitioner received to the agency action or proposed action; (d) A statement of all disputed issues of material fact.

as the rules and statutes which entitle petitioner to relief; (f) A statement of the specific rules or statutes the petition contends require reversal or modification of the agenc proposed action; and,

(g) A statement of the relief sought by the petitioner, stati precisely the action petitioner wishes the agency to to with respect to the agency's proposed action.

A petition that does not dispute the material facts up which the permitting authority's action is based shall stath that no such facts are in dispute and otherwise shall ca tain the same information as set forth above, as requirely Rule 28-106.301, F.A.C.
