The current Title V Permit and associated PSD Permit lists Santa Rosa Energy, LLC as the owner of the Santa Rosa Energy Center. Calpine Corporation, parent company of Santa Rosa Energy, LLC, has decided to subsume its subsidiary. Therefore, Calpine Corporation requests the owner's name on the subject permit be changed to Calpine Corporation. The name change in the ownership will be effective on or about July 16, 2003. Neither the Responsible Official nor the Designated Representative is expected to change.
