I reviewed the permit and it looks like the change can be handled with a letter. The emissions unit description of the smaller cylinder does not state that CCS will not be used and can be revised to include CCA. The specific conditions and recordkeeping language for the emissions unit will not require any changes. The language, as currently written, covers both the large and small cylinder.

One last item, has the Public Notice been published and if so, please be sure to mail me the proof of publication.
