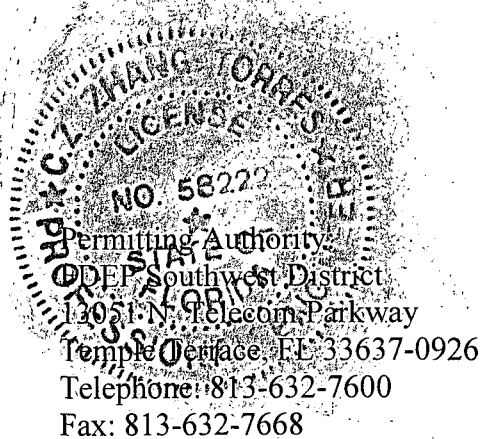

On April 17<sup>th</sup>, 2007, the Department received a construction/renewal permit application from Global Tire Recycling Of Sumter County, Inc. to renew the operation permit for their crumb rubber manufacturing facility. The operation permit for this facility expired on October 13<sup>th</sup>, 2004, and the facility just recently applied to renew their permit.

The compliance inspector, Arthur Bosshart, informed me via email on 4/23/2007, that he conducted an inspection of the facility on 3/21/2007 and discovered their permit had expired. As a result, he submitted referral for enforcement to Danielle Henry. Based on his inspection, he found that operation of the facility and equipment had not changed and the expired permit descriptions were still valid.

Danielle Henry informed me via email on 5/03/2007 that the facility had an enforcement referral in-house and a warning letter would be sent to the facility. She also stated that there were no other enforcement issues discovered at the facility.

After reviewing the permit application, a request for additional information letter was mailed on 5/7/2007. This letter was a request for clarification of production rate listed in the application. Two different values were listed for a production rate that is also a permit limit in previous permits. A response letter containing the requested information was received on 5/29/2007. The response included the correct production rate along with corrected emission calculations. Since the permitted production rate of the facility was affected by this information, a construction permit is necessary.

Visible emissions tests were conducted on 4/10/2007 and showed compliance with the permit VE limitations.

I recommend the Intent to Issue for Global Tire Recycling Of Sumter County, Inc. be signed.

This project is for the permit renewal and construction modification of an existing, synthetic non-Title V, crumb rubber manufacturing facility. The construction modification will increase the maximum process production rate from 20,000 tons/year to 26,280 tons/year. The facility manufacture crumb rubber 1/8 to 3/8 inch in diameter. The facility located at 1201 Industrial Drive, Wildwood, Sumter County.

**D. Process and Controls:**

This permit is for the operation of a synthetic non-Title V crumb rubber manufacturing facility. This facility consists of (1) waste tire receiving, storage and staging areas, (2) a rotary shear type tire shredder, (3) two cracker mills in series with hooded air separator screens, (4) three fine grind mills in parallel with hooded air separator screens, (5) intermediate and final product storage bins, and (6) final product bagging and bulk loadout bins.

In this process, waste tires are passed through a shredder that reduces the tires to 2-4 inch chips. The chips are then passed through two cracker mills that further reduce the size of the chips and separates the fiber, metal tread and cord material from the rubber. The metal is removed with magnets and the fiber and other foreign material is removed on air aspirated screening tables and gravity tables. The separation process results in debris free rubber 1/8 to 3/8 inch in diameter. Oversized rubber is fed back into the cracker mills. Fine grinding mills then reduce the rubber to mesh-sized crumb rubber product. Each fine grind mill is followed by an air aspirated screening operation. Oversize material is feed back to the fine grind mills. The final product is then conveyed via a screw elevator to a loadout hopper for bagging or bulk shipment to customers.

Particulate matter emissions from the air aspirated screening processes are vented through a common baghouse (MAC Environmental, Model 144WMCF338) before being discharged to the atmosphere. Because of the enclosure of the process and the nature of the raw material and the product, there are no significant fugitive emissions associated with this process.

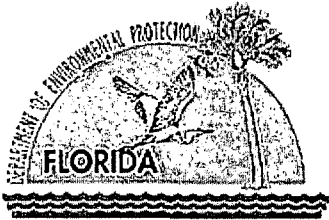


