Dear Mr. Graves:

This is to acknowledge that the Animal Crematory Air General Permit Registration Form for your facility located at 680 Southland Avenue Suite 1, Bushnel, FL 33597, was received on June 7, 2007. We have assigned ARMS number 1190044-002-AG to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty (30) days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, your use of this general permit is limited to five (5) years, pursuant to Rule 62-210.310(3), F.A.C. A new registration form must be received by the Department no later than **June 7**, **2012**, which contains all current information regarding the facility and/or emissions unit(s).

The owner or operator of any animal crematory using an air general permit shall have a performance test conducted for visible emissions no later than thirty (30) days after commencing operation, and annually thereafter (within 365 days from last compliance test), pursuant to Rule 62-296.401(6)(h), F.A.C.
