Dear Mr. Messer:

On September 29, 2008, the Department received your application and sufficient fee for an air construction permit to allow the use of ASR, also known as "auto fluff" for a trial period at Suwannee American Cement Plant. The facility is located in Suwannee County at 5117 U.S. Highway 27 in Branford, Florida. The application was deemed incomplete and the Department requested additional information on March 20, 2009 that would allow continued processing of your application. We have not yet received the requested additional information. Rule 62-4.055(1) of the Florida Administrative Code (F.A.C.) requires the following:

"The applicant shall have ninety days after the Department mails a timely request for additional information to submit that information to the Department. If an applicant requires more than ninety days in which to respond to a request for additional information, the applicant may notify the Department in writing of the circumstances, at which time the application shall be held in active status for one additional period of up to ninety days. Additional extensions shall be granted for good cause shown by the applicant. A showing that the applicant is making a diligent effort to obtain the requested additional information shall constitute good cause. Failure of an applicant to provide the timely requested information by the applicable deadline shall result in denial of the application."

It has been more than 65 days since our request for additional information (copy attached). You are reminded that the permit processing time clock has stopped for this project and that we will not continue our review until we receive the additional information. If you require a period of time in addition to the 90 days allowed by rule, please submit a written request indicating the amount of time necessary. If you fail to provide the additional information or request additional time to submit the additional information, the Department will deny your application for air permit. Dear Mr. Messer:

On February 19, 2009, the Department of Environmental Protection (Department) received your response to our third request for additional information (RAI) that was dated February 13, 2009. After review of your response, the Department requests submittal of the additional information indicated below to address concerns with regard to the use of automobile shredder residue (autofluff) as an alternative fuel at SAC prior to processing the application. Should your response to any of the below items require new calculations, please submit the new calculations, assumptions, reference material and appropriate revised pages of the application forms.

- 1. Polychlorinated biphenyls (PCB) have been detected in autofluff. The PCB may come from variety of sources including: insulating materials in capacitors for appliances manufactured prior to 1979, insulating materials in transformers, softening agents for plastics, hydraulic fluids, lubricants and heat transfer coolants. Although there are several programs to eliminate PCB from entering the autofluff stream, PCB levels continue to be detected in autofluff. We have information that regulatory requirements under the Toxic Substances Control Act (TSCA) created issues with autofluff as an acceptable alternative fuel. It is our understanding that the autofluff supplier must certify that all chemical substances in each autofluff shipment complies with all applicable rules and orders under the TSCA. Please provide additional information regarding the quality assurance and quality control procedures that will be used to ensure that the autofluff will not contain significant amounts of PCB and comply with the TSCA provisions. Provide examples of the documentation that will be used to satisfy the federal requirements for certification, testing, record keeping and reporting under 40 CFR 761.185 and 193.
- 2. For any trial of autofluff, it will be necessary to monitor the mercury emissions from the kiln. Please provide cost estimates for the use and analysis of mercury sorbent traps and the use of a continuous emissions monitoring system to measure and record mercury emissions. The cost estimates should consider appropriate monitoring for each of the various requested operating scenarios (autofluff/coal

and raw mill on, autofluff/coal and raw mill off, autofluff/coal/fly ash and raw mill on, autofluff/coal/fly ash and raw mill off, etc.) for the duration of the trial.

The above information is requested pursuant to the following F.A.C. regulations: Rule 62-4.050 (Procedures to Obtain Permits and Other Authorizations; Applications); 62-4.055 (Permit Processing); 62-4.070 (Standards for Issuing or Denying Permits; Issuance; Denial); 62-4.120 (Construction Permits); 62-204.800 (Federal Regulations Adopted by Reference); 62-212.300 (Permits Required); 62-210.370 (Emissions Computations and Reporting); 62-210.900 (Forms and Instructions); 62-212.300 (General Preconstruction review); and 62-212.400 (Preventions of Significant Deterioration). All applications for a Department permit must be certified by a professional engineer registered in the State of Florida pursuant to Rule 62-4.050(3), F.A.C. This requirement also applies to responses to Department requests for additional information of an engineering nature. For any material changes to the application, please include a new certification statement by the authorized representative or responsible official.

We will resume processing your application after receipt of the requested information. You are reminded that Rule 62-4.055(1), F.A.C. requires applicants to respond to requests for information within 90 days or to provide a written request for an additional period of time to submit the information.
