I hope that the oversight did not present any problems for your Department. If you have any questions, please contact me at (386) 575-5385.

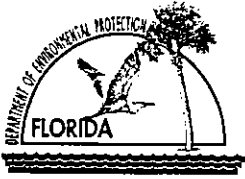


