

Attached is the Final air construction permit, Project No. 7770073-010-AC.

The subject of the permit is to authorize the construction of a 300 TPH portable hot drum-mix asphalt concrete plant and its relocation from Okeechobee County to 12955 40<sup>th</sup> Street North, Clearwater, Pinellas County; and, the permit authorizes the periodic use of a permitted portable crusher unit with a maximum capacity of 250 TPH. The applicant requested the terms and conditions pursuant to Rule 62-210.300(3)(c)2., F.A.C., Conditional Exemption from Title V Permitting – Asphalt Concrete Plants.

There were no comments received during the Public Notice period. Therefore, it is recommended that the Final air construction permit be signed as noticed.
