

Attached is the Final air pollution construction (AC) permit, Project No. 7770073-011-AC.

On May 29, 2007, the Department issued AC permit No. 7770073-010-AC for APAC-Southeast, Inc. – Central Florida Division. The AC permit expires on May 31, 2008. The AC permit authorized the relocation of an existing 300 tons/hour portable drum-mix asphalt plant from Okeechobee County to 12955 40<sup>th</sup> Street North, Clearwater, Pinellas County; and, the permit authorized the periodic use of a permitted portable crusher unit with a maximum capacity of 250 TPH. On February 25, 2008, the Department received a request and processing fee to extend the expiration date of the AC permit from May 31, 2008, to May 31, 2009. The expiration date extension will allow the permittee additional time to complete the move, reassemble the plant, conduct any performance tests, submit the test results and apply for an air operation permit. On February 27, 2008, a phone call was made to Mr. Gary Robbins with Pinellas County regarding the request and he expressed no opposition to the granting of the expiration date extension.



### **I. Technical Evaluation.**

An Intent to Issue an Air Construction Permit to APAC Southeast, Inc. – Central Florida Division, for authorization to relocate their portable asphalt concrete plant from Okeechobee County to 12955 40<sup>th</sup> Street North, Clearwater, Pinellas County, was clerked on May 8, 2007. The Public Notice of Intent to Issue an Air Construction Permit was published in the St. Petersburg Times on May 12, 2007. Proof of publication of the Public Notice of Intent to Issue an Air Construction Permit was received on May 21, 2007. Since no comments were received during the Public Notice period of the Draft air construction (AC) permit, then the Final AC permit No. 7770073-010-AC was issued on May 29, 2007, with an expiration date of May 31, 2008. On February 25, 2008, a request was received to extend the expiration date to May 31, 2009, to allow the permittee additional time to complete the move, reassemble the plant, conduct any performance tests, submit the test results and apply for an air operation permit.

### **II. Preliminary Determination.**

Since no comments were received during the Public Notice period of the initial AC permit and there were no third party participants in the initial permitting action, then no additional notifications were deemed necessary by the Permitting Authority, the Bureau of Air Regulation, in order to process this request to extend the expiration date of the initial AC permit. On February 27, 2008, Mr. Gary Robbins with the Air Quality Division of the Pinellas County Department of Environmental Management was called regarding the request and he expressed no opposition to the expiration date being extended.

### **III. Final Determination.**

In conclusion, the permitting authority hereby issues this Final Air Construction Permit, project No. 7770073-011-AC, amending AC permit No. 7770073-010-AC and extending the expiration date from May 31, 2008, to May 31, 2009.

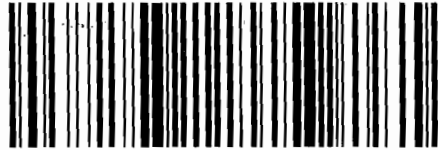
