## ATTACHMENT 2

### **Fugitive Dust Control:**

To control fugitive dust emission from this facility, the best management practice such as the following will be incorporated into the daily operations:

1. All storage material will be kept in a confined area and wetted as needed.
2. The unpaved roads will be sprayed with water on an as needed basis.
3. Care will be exercised while transporting materials to minimize overfilling and spillage.

## ATTACHMENT 3

### Mobile Rock Crusher

#### Fugitive Emission Factors:

**From: Storage Piles at 35,000 tons stored AP.42 - Section 11.2.3**

PM 0.0087 lbs/ton

$$35,000 \times 0.0087 = 304.5 \text{ lbs } 0.15 \text{ TPY}$$

**From: Unpaved Road 0.33 lbs/VMT**

$$0.33 \times 0.5 \text{ VMT} = 0.165 \text{ lbs/hr } 0.165 \text{ TPY}$$

$$(0.165)(2000 \text{ hrs/yr}) =$$

$$\text{Total } \quad \mathbf{0.15 + 0.165 = 0.215 \text{ TPY}}$$

## ATTACHMENT 4

### O&E MANUAL

**Primary Crusher** - visually check bearings, wear items, safety guards, grease all on daily basis.

**Secondary Crusher** - visually check bearings, wear items, safety guards, grease all on daily basis.

**Screens** - check to make sure screens are secured daily, check for damage to screens, grease and safety check daily.

**Conveyor Belts** - check daily for bearings, safety, tears in belts.

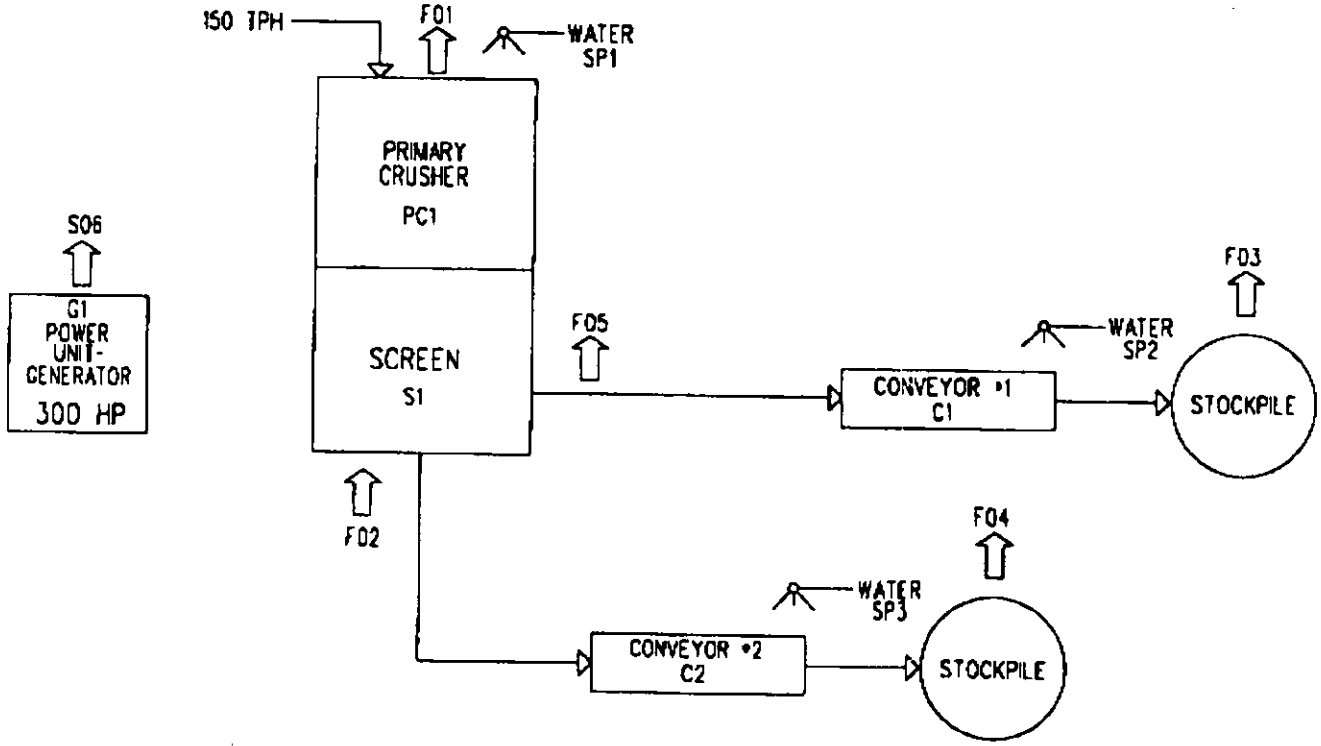
**Water Nozzle** - check hourly, and daily to make sure they stay properly positioned for the best control on all controlled places.

**Water Pump** - Make sure pump is checked and properly operating on a daily basis.

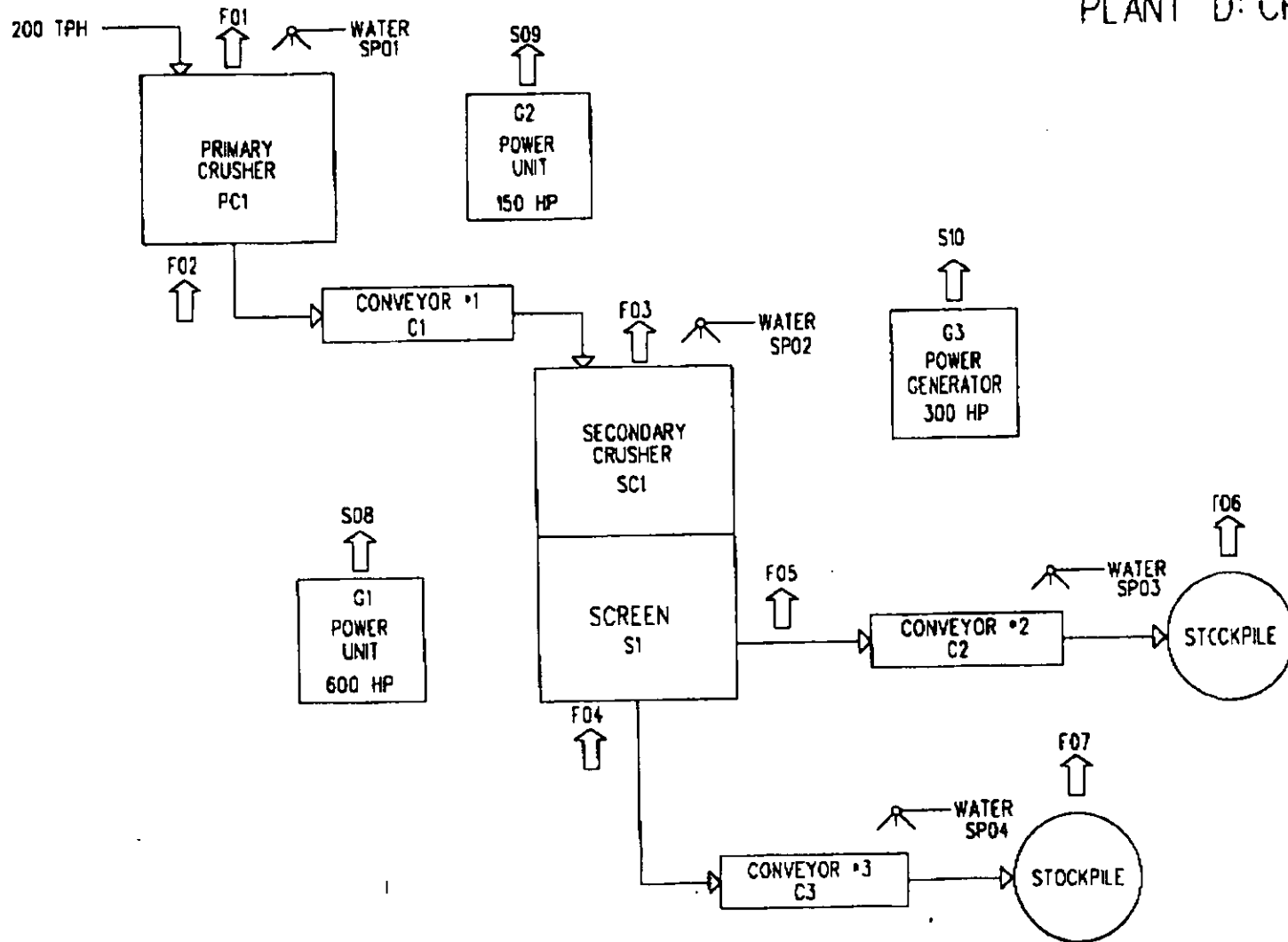
**Power Units** - Check engine oil and water daily, make sure all guards are in place.

**Loader** - Check daily general maintenance, oil, water, wear, tires.

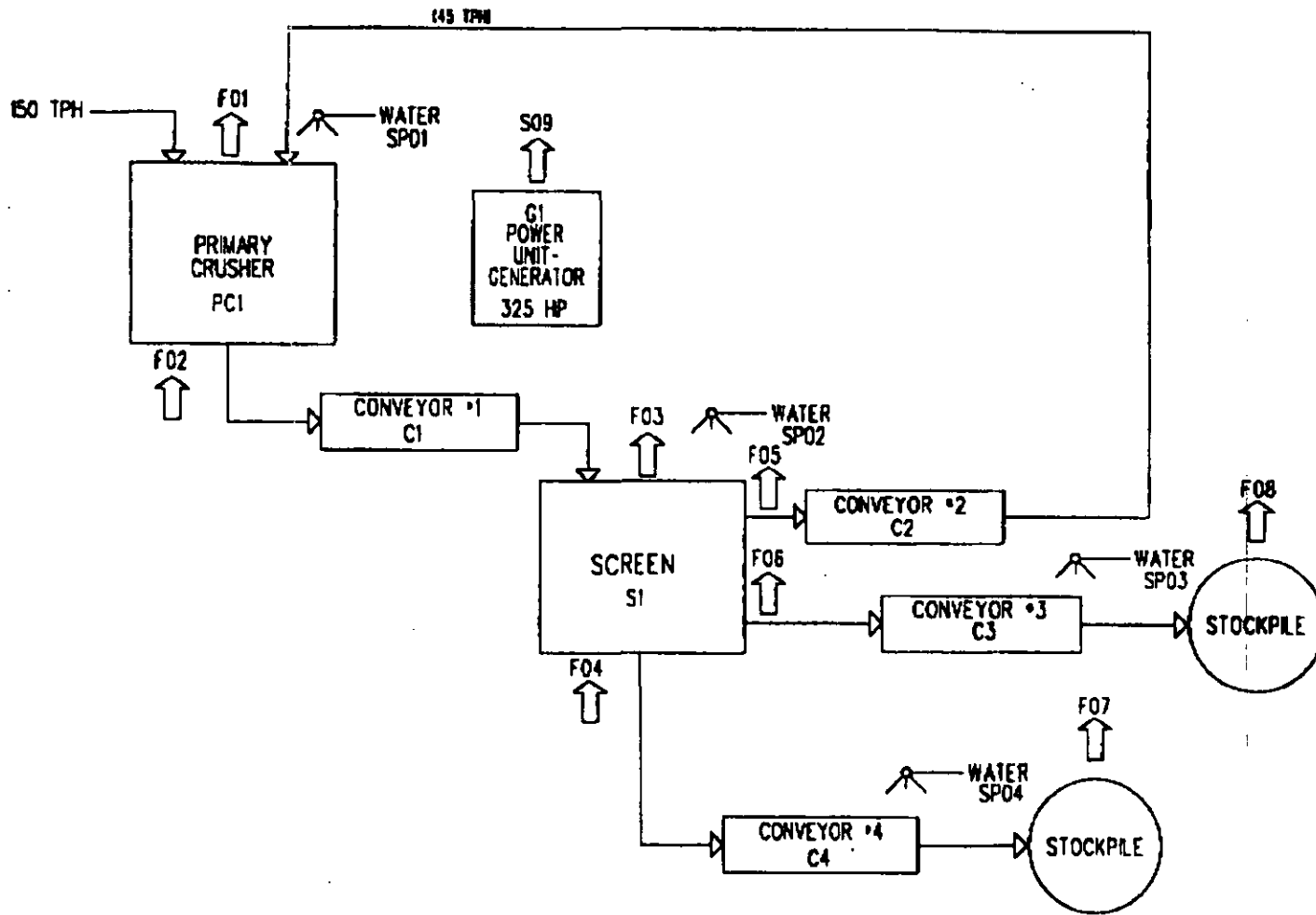
PLANT ID: CP03


The Department has reviewed your application for permits to construct three mobile concrete and asphalt material crushing units that was received in this office on October 7, 1997. We need the additional information/clarification listed below to process this request.

1. List the key components of the facility. Give make and model number of the equipment when available.
2. Provide a process flow diagram and brochure, if available, on the crusher system.
3. Describe how fugitive dust from this operation will be controlled.
4. Estimate the fugitive particulate matter emissions from each crusher. Use of AP-42 emissions factors to calculate these emissions will be acceptable.
5. Can this unit be operated in compliance with the visible emissions standards of 10 percent opacity for conveyors and 15 percent opacity for crushers specified in the new source performance standard (40 CFR 60, Subpart OOO) and a visible emission standard of 5 percent opacity as required by the particulate matter Reasonably Available Control Technology regulations (Rule 62-296.711, F.A.C.)?
6. Please provide an Operation and Maintenance plan for the crusher unit, including the water spray system used to control fugitive emissions.
7. Please provide a copy of the existing air construction permits for these facilities.
