
Dear Ross Pollock;



The Department of Environmental Protection (Department) gives notice of its intent to issue an air construction permit to I.R.S. Concrete Recycling, Inc. for a diesel engine powered portable concrete and asphalt material crusher that will be operated in southeast Florida. The crusher is a minor source of air pollution and not subject to the Prevention of Significant Deterioration (PSD) regulations, Rule 62-212.400, F.A.C. A Best Available Control Technology determination was not required for the unit. The applicant's name and address are: I.R.S. Concrete Recycling, Inc., 969 Barral Avenue, Ft. Pierce, Florida 34982.

The applicant proposes to construct and operate this unit in counties in Florida that this notice appear in. The crusher will emit particulate matter and the products of combustion from the diesel fuel.

Maximum emissions of pollutants from this facility (crusher and a diesel engines) are estimated to be:

Pollutant	Hourly Emissions pounds per hour	Annual Emissions tons per year
Particulate matter (PM/PM10)	2.9	3.0
Nitrogen Oxides (NOx)	3.2	3.3
Carbon Monoxide (CO)	1.8	1.8
Sulfur dioxide (SO2)	0.5	0.5
Volatile Organic compounds (VOC)	0.2	0.2

The facility is not expected to cause or contribute to any violation of an ambient air quality standard.

The Department will issue the FINAL Permit, in accordance with the conditions of the DRAFT Permit unless a response received in accordance with the following procedures results in a different decision of significant change of terms or conditions.

The Department will accept written comments concerning the proposed DRAFT Permit issuance actions for a period of 14 (fourteen) days from the date of publication of this Notice. Written comments should be provided to the Department's Bureau of Air Regulation, 2600 Blair Stone Road, Mail Station #5505, Tallahassee, Florida 32399-2400. Any written comments filed shall be made available for public inspection. If written comments received result in a significant change in this DRAFT Permit, the Department shall issue a Revised DRAFT Permit and require, if applicable, another Public Notice.

The Department will issue the FINAL Permit with the conditions of the DRAFT Permit unless a timely petition for an administrative hearing is filed pursuant to Sections 120.569 and 120.57, F.S. Mediation is not available for this proposed action. The procedures for petitioning for a hearing are set forth below.

A person whose substantial interests are affected by the Department's proposed permitting decision may petition for an administrative proceeding (hearing) in accordance with Section 120.569 and 120.57, F.S. The petition must contain the information set forth below and must be filed (received) in the Office of General Counsel of the Department at 3900 Commonwealth Boulevard, Mail Station 35, Tallahassee, Florida 32399-3000, telephone: 850/488-9370, fax: 850/487-4938. Petitions must be filed within fourteen (14) days of publication of this notice, or within fourteen days of receipt of this notice of intent, whichever occurs first. A Petitioner must mail a copy of the petition to the applicant at the address indicated above at the time of filing. The failure of any person to file a petition (or for a request for mediation, as discussed below) within the appropriate time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57, F.S., or to intervene in this proceeding and participate as a party to it. Any subsequent intervention will be only at the approval of the presiding officer upon the filing of a motion in compliance with Rule 28-5.207 of the Florida Administrative Code.

A petition must contain the following information: (a) The name, address, and telephone number of each petitioner, the applicant's name and address, the Department Permit File Number and the county in which the project is proposed; (b) A statement of how and when each petitioner received notice of the Department's action or proposed action; (c) A statement of how each petitioner's substantial interests are affected by the Department's action or proposed action; (d) A statement of the material facts disputed by petitioner, if any; (e) A statement of facts which petitioner contends warrant reversal or modification of the Department's action or proposed action; (f) A statement of which rules or statutes petitioner contends require reversal or modification of the Department's action or proposed action; and (g) A statement of the relief sought by petitioner, stating precisely the action petitioner wants the Department to take with respect to the Department's action or proposed action addressed in this notice of intent.

Because the administrative hearing process is designed to formulate final agency action, the filing of a petition means that the Department's final action may be different from the position taken by it in this Notice of Intent. Persons whose substantial interests will be affected by any decision of the Department with regard to the application have the right to petition to become a party to the proceeding in accordance with the requirements set forth above.
