# Designated Representative Agreement for Indian River Plant and

**Stanton Energy Center** 

By and Between
Orlando Utilities Commission

Frederick F. Haddad, Jr. and Gregory A. DeMuth

THIS AGREEMENT, made as of the 9th day of April 1996, is by and between Orlando Utilities Commission, a Statutory Commission, Frederick F. Haddad, Jr., an individual, and Gregory A. DeMuth, an individual (all collectively referred to as the "Parties" or, in the singular, as the "Party").

#### WITNESSETH:

WHEREAS, the Indian River Plant (IRP) and Stanton Energy Center (SEC) are affected sources under Title IV (the "Acid Rain Program") of the Clean Air Act Amendments of 1990 (the "Act") (PL 101-549) and are owned by the Orlando Utilities Commission (OUC).

WHEREAS, the Acid Rain Program requires the owners and operators of each affected source to designate a natural person to represent the source in matters pertaining to the Acid Rain Program requirements, including the holding, transfer or disposition of allowances allocated or the units at the affected source and the submission of permit applications, compliance plans and monitoring information for the affected source; and

WHEREAS, the rules to implement the Acid Rain Program ("Acid Rain Program Rules," to be codified at 40 C.F.R. Parts 72-78) allow the owners and operators of an affected source to designate an alternative representative to represent the source in matters pertaining to the Acid Rain Program;

NOW, THEREFORE, the Parties hereto agree for good and adequate consideration to the following terms and conditions.

## I. APPOINTMENT OF A DESIGNATED REPRESENTATIVE AND AN ALTERNATE DESIGNATED REPRESENTATIVE

The Parties agree that Frederick F. Haddad, Jr. shall be appointed as the Designated Representative ("DR") and Gregory A. DeMuth shall be appointed as the Alternate Designated Representative ("ADR") to represent OUC, as Owner of IRP and SEC, in all matters pertaining to the Acid Rain Program.

#### II. FILING OF CERTIFICATES OF REPRESENTATION

Pursuant to the Acid Rain Program Rules, the DR and ADR must file a Certificate of Representation, EPA Form 7610-1, (copy attached) with the Administrator of the United States Environmental Protection Agency ("EPA"), to be authorized to represent an affected source in matters pertaining to the Acid Rain Program. Frederick F. Haddad, Jr. and Gregory A. DeMuth, as the DR and ADR, respectively, agree to file a Certificate of Representation with the Administrator of the EPA, in accordance with 40 C.F.R. § 72.24, upon execution of this Agreement. Frederick F. Haddad, Jr. and Gregory A. DeMuth shall be authorized to represent and legally bind OUC, as the DR and ADR, respectively, upon receipt of the Certificate of Representation by the Administrator of the EPA.

#### III. RIGHTS AND OBLIGATIONS OF THE DR AND THE ADR

- A. The DR and ADR shall have the rights and obligations specified in the Act and the Acid Rain Program Rules.
- B. The ADR shall have the authority to sign and certify submissions to the EPA or any other applicable permitting authority in lieu of the DR whenever the DR is unavailable. The term "unavailable" shall include, but not be limited to, illness or absence from the premises of IRP or SEC.
- C. If conflicting actions are taken by the DR and the ADR, the actions of the DR shall take precedence.

#### IV. ALLOWANCE TRANSFERS

All transfers of allowances shall be executed by the DR.

#### V. TERMINATION

- A. This Agreement may be terminated by any Party upon 30 days written notice. Frederick F. Haddad, Jr. and Gregory A. DeMuth agree to continue to represent OUC, as DR and ADR, respectively, until a superseding Certificate of Representation is filed with the Administrator of the EPA.
- B. If Frederick F. Haddad, Jr. or Gregory A. DeMuth should leave the employment of OUC, their authority to act as DR or ADR shall cease immediately upon termination of employment. The DR or ADR shall give 30 days prior written notice of any voluntary termination of employment and the DR shall assist in the selection of and filing of a Certificate of Representation for any successor DR selected by OUC.

VI. To the extent permitted by law, OUC agrees to indemnify and hold the DR and ADR harmless from and against any losses, liabilities, costs, expenses, suits, actions, claims and all other obligations and proceedings whatsoever, including without limitation, all judgments rendered against and all fines and penalties imposed upon the DR and ADR, for any reasonable attorneys' fees and any other costs of litigation (hereinafter referred to as "liabilities") arising out of this Agreement, including without limitation, injuries to persons or damage to property caused by, or in any way attributable to, the performance of the DR's or ADR's duties pursuant to this Agreement, except that OUC's obligation to indemnify the DR or ADR shall not apply to any liabilities to the extent the liabilities arise from the DR's or ADR's gross negligence or are the direct consequences of the DR's or ADR's fraudulent or dishonest conduct. If this indemnity provision is unenforceable under the applicable state law, this Article shall be interpreted to impose the maximum legal obligation permitted under such law.

#### VII. APPLICABLE LAWS AND JURISDICTION

Except to the extent federal law as evidenced in the Acid Rain Program is applicable, the rights and obligations of the Parties arising out of this Agreement shall be governed in all respects by the laws of the State of Florida.

IN WITNESS WHEREOF, the Parties hereto have caused this Agreement to be executed as of the date first above written.
