
Dear Mr. Linero:

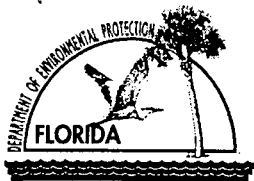
