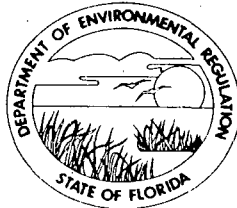

Dear Mrs. Bernardo:

Secretary Tschinkel has asked me to respond to your letter and resolution, which was passed by your Board on July 29, 1986, and which supports the use of scrubbers and baghouses to control the air emissions from the proposed North Broward County Resource Recovery Facility.

The Department's Bureau of Air Quality Management, which has been reviewing that portion of the proposed facility's application which concerns air quality issues, is in agreement with your Association's position on the type of technology the proposed facility should utilize to control its air emissions. However, the Bureau of Air Quality Management has recommended to the Secretary that due to a number of policy issues associated with the determination of what constitutes Best Available Control Technology for these facilities, that regulations should be adopted by the Environmental Regulation Commission that would better enable the Department to regulate the facility's air emissions. Thus, the Department is going to recommend that Broward County leave space in the design and construction of the facility to retrofit the facility with more stringent air pollution control equipment, pending the adoption of new regulations by the Environmental Regulation Commission. A rule adoption schedule has been proposed by the Bureau of Air Quality Management, which anticipates rule adoption by the Environmental Regulation Commission during Spring, 1987.

RESOLUTION ADOPTED BY THE BOARD OF DIRECTORS OF CRYSTAL LAKE GOLF  
VILLAS. ASSOC., INC., PHASE II

WHEREAS, Broward County proposes the construction of a waste disposal plant at or near the intersection of N.W.48th Street and Powerline Road, Broward County, and it is estimated that said plant will operate 24 hours a day and consume 1760 to 2200 tons of garbage daily, and

WHEREAS, Crystal Lake Golf Villas, Assoc., II, is adjacent to the aforesaid disposal plant, and the health and welfare of its some 600 residents, as well as the health and welfare of the 25000 plus of other residents in nearby retirement communities and other Broward County residents living nearby, may be adversely affected, and the quality of life of these residents be damaged, and

WHEREAS, THE DEPARTMENT OF ENVIRONMENTAL REGULATIONS, as well as many other highly qualified environmental experts have strongly recommended the installation of the best available control equipment, including scrubbers and baghouse filters which will substantially reduce the levels of acids, toxic particles and ashes carried into the atmosphere and experts in the field have estimated that without proper controls and state of the art devices, an estimated nine million pounds of hydrochloric acid and gas, and 168 tons of sulphuric acid mist will be emitted annually from the proposed plant, and

WHEREAS The Board of Directors of Phase II, Crystal Lake Golf Villas, Assoc. has voted the adoption of a motion to support a resolution as aforesaid, it is,

NOW, on motion duly made and seconded,

RESOLVED, That this Board of Directors vigorously supports and adopts the resolution requiring the Broward County Commissioners to insist that the North Broward Resource Recovery Plant include such scrubbers, baghouse filters and any other equipment or accessories which may be essential to achieve the aforesaid purpose and,

IT IS RESOLVED FURTHER, that a copy of this Resolution be forwarded to each of the Broward County Commissioners and any other legal entity involved with the design and construction of aforesaid waste disposal plant.
