
**Rule 62-4.050, F.A.C. Procedures to Obtain Permits and Other Authorizations;

With the completion of compliance stack testing in March of 2001, all conditions in Subsections A of the Wheelabrator North Broward (0112120-001-AV) and South Broward (0112119-002-AV) Title V permits are no longer applicable. As per our telephone conversation of 6/6/02, in addition to the 15 hour excess CO emission modification request originally submitted to the Department on May 6, 2002, Wheelabrator is requesting that all conditions in Subsections A be removed from each facility's Title V permit.

Thank you for your letter received June 26, 2002, written in response to our letter dated June 5, 2002, concerning certain incompleteness items needed to process your request for a minor modification to the referenced facility PSD permit for the construction of a wet scrubber at the ash handling building. We note that the attachment to your letter also includes an application for a Title V permit revision for the facility to add this new emissions unit.

However, we must deem your application still *incomplete*, because we need engineering justification details for the claim that the PM emission rate from the wet scrubber outlet for the ash handling building is 0.03 grains per dry standard cubic foot (noted on page one of the application package).

When we receive this information, we will continue processing your application request (i.e., the joint PSD permit minor modification and the Title V revision). If you have any questions, please contact Tom Cascio at 850-921-9526.

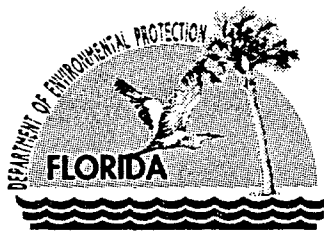

The Department has received your request dated December 11, 2002 for a determination of a waste categorization. The request addresses the disposal of unprocessed tobacco leaf as contraband. Since the waste is a plant material; under the control of the USDA; and, it is the intent of the USDA to have this waste material destroyed, it is the opinion of the Department that this waste material meets the intent of specific conditions **B.15.(4)(b)** of permit 0112119-006-AV and **B.16.(4)(b)** of permit 0112120-005-AV. This material may be combusted at either facility, provided compliance with all other applicable conditions is maintained.

Dear Mr. Svec:

Wheelabrator North and South Broward have the opportunity to dispose of approximately 30,500 tons/facility of unprocessed tobacco leaf presently under the control of the USDA. It is Wheelabrator's belief that this material should be categorized as contraband according to the facility Title V permits (No. 0112120-005-AV for North Broward and No. 0112119-006-AV for South Broward) condition B.16. (4) (b) for North Broward and condition B.15. (4) (b) for South Broward. The reasoning behind this belief is that the material is a "drug", "narcotic" or "plant" and is being disposed of through "authorized local, state or federal agencies" as stated in these conditions.

Wheelabrator North and South Broward are requesting a written or e-mail response from the Department as to the acceptability of this material in accordance with the conditions referenced above.

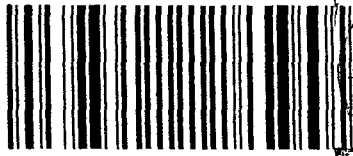

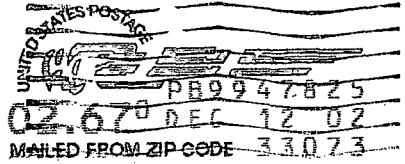
