PUBLIC NOTICE OF INTENT TO ISSUE AIR PERMIT

Florida Department of Environmental Protection

Applicant: The applicant for this project is the United States Sugar Corporation. The applicants authorized representative is Mr. William A. Raiola, Senior V.P. of Sugar Processing Operations. The applicants mailing address is the Clewiston Sugar Mill and Refinery, 111 Ponce DeLeon Avenue, Clewiston, FL 33440.

Facility Location: The United States Sugar Corporation operates an existing sugar mill and refinery in Clewiston at the intersection of W.C. Owers Avenue and State Road 832 in Hendry County, Florida.

Project: The applicant proposes to replace the existing oil burner systems for Bollers 1 and 2 with new low-NOx burners. The bollers currently fire No. 6 fuel oil containing up to 2.5% suffur by weight as a startup fuel and to supplement bagasse. The new system allows the firing of cleaner distillate oil containing no more than 0.05% suffur by weight. Bagasse will remain the primary fuel with distillate oil used as a startup let and to supplement bagasse. These bollers supply steam to the mild during the suparcane crop season and serve as backup units during the off-crop season for the refinery.

The edisting Clewiston sugar mill/refinery is a major facility in accordance with Rule 62-212.400, F.A.C., the regulatory program for the Prevention of Significant Deterioration (PSD) of Air Quality. The edisting facility is located in Hendry County, which is an area that is currently in attainment with the state and federal Amblent Air Quality Standards (AAQS) or otherwise designated as unclassifiable. The project does not result in emissions increases that exceed the PSD significant emission rates specified in Rule 62-212.400, F.A.C. based on the application, past actual emissions, the requested restrictions, and representative emission factors for these units. Therefore, the project is not subject to PSD preconstruction review.

Permitting Authority: Applications for air construction permits are sublect to review in accordance with the provisions of Chapter 403, Florida
Statutes (F.S.) and Chapters 62-4, 52-210, and 62-212 of the Florida Administrative Code (F.A.C.). The proposed project is not exempt from air
permitting requirements and an air permit is required to perform the proposed work. The Florida Department of Environmental Protection's Bureau of Air Regulation is the Permitting Authority responsible for making a
permit determination for this project. The Bureau of Air Regulation's

Notice of Intent to Issue Air Permit: The Permitting Authority gives notice of its intent to issue an air permit to the applicant for the project described above. The applicant has provided reasonable assurance that operation of proposed equipment will not adversely impact air quality and that the project will comply with all appropriate provisions of Chapters 52-4, 52-204, 62-210, 62-215, 62-295, and 62-297, FAC. The Permit and Authority will issue a Final Permit in accordance with the conditions of the proposed Draft Permit unless a timely petition for an administrative hearing is filed under Sections 120.599 and 120.57, F.S. or unless public comment received in accordance with this notice results in a different decision or a significant change of terms or conditions.

Comments: The Permitting Authority will accept written comments concerning the Draft Permit for a period of fourteen (14) days from the date of publication of the Public Notice. Petitions filed by the applicant or any of the parties listed below must be filed within tourteen (14) days of receipt of this Written Notice of Intent to Issue Air Permit, Petitions filed by any persons other than those entitled to written notice under Section 120,60(3), F.S., must be filed within tourteen (14) days of publication of the attached Public Notice or within fourteen (14) days of receipt of this Written Notice of writtin fourteen (14) days of receipt of that notice, regardless of the date of publication. A petitioner shall mail a copy of the petition to the applicant at the address indicated above, at the time of filing. The failure of any person to file a petition within the appropriate time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120,559 and 120,57, F.S., or to intervene in this proceeding and participate as a party to it.
