The Department gives notice of its intent to issue a permit to the Kennedy Space Center to authorize construction of a hot water generator.

The 25 million Btu/hr hot water generator will replace an existing 13.7 million Btu/hr generator. The generator will burn No. 6 fuel oil with a maximum sulfur content of one percent (1.0%). A Best Available Control Technology (BACT) determination was not required for this project.

INTENT TO ISSUE

The Department of Environmental Regulation hereby gives notice of its Intent to Issue, and proposed order of issuance for, a permit pursuant to Chapter 403, Florida Statutes, for the proposed project as detailed in the application specified above. SUBJECT: Review of EPA's proposed "Guidelines for Auditing Motor Vehicle Emissions Inspections Programs - FY 1985"

Although very informative, these guidelines pertain chiefly to areas conducting I/M or vehicle emissions testing programs. Because Florida does not have an I/M or similar program currently implemented or scheduled for FY 1985, it would be difficult for us to determine whether or not the information included in the proposed guideline is complete. However, the document appears very well researched and could be a useful tool for us to use, if needed, for future reference.

Section 3.3; first paragraph: A standardized report format would be useful to ensure uniform reporting of I/M programs audited. In addition, a standard formatted report should be easier to process, thus speeding up "turnaround time" in returning useful comments to the state/local programs audited. Every effort should be taken to expedite EPA audits and return comments to the I/M program managers.

Mr. James Lents Page Two November 30, 1984

- 6-23 Section 3; first paragraph: EPA program licensing policy should also include mandatory yearly training of I/M inspectors. This will help ensure that inspectors remain current after the introduction of new model (technology) automobiles.
- 6-24 Section 4; third paragraph, et. al.: It would be useful if EPA proposed standardizing analyzer specifications and functions. Although difficult because of our free enterprise market, the uniform and verifiable data that could become available would be useful in comparing cost/benefit effectiveness, etc., of the I/M programs.
- Section 10; #3, first paragraph: EPA should require I/M programs to present this information and additional consumer information to the customer when the inspected vehicle fails the emission test. Public information and consumer protection should be maximized to assure a successful I/M program.

Section 11; first paragraph, et. al.: A comprehensive mechanics training program that would lead to a certified emissions mechanic designation should be implemented to protect the consumer and ensure only qualified mechanics repair emissions control equipment. A provision should also be available to allow owners the option to repair their own vehicles.

6-69 Section III; second paragraph: In addition to the three contractor personnel and one EPA representative, state and local agencies should be notified and given the option to have staff present at the vehicle emission control equipment surveys.

Section IV; under "Suggested Equipment", add the following:

- orange safety cones and directional (arrow) signs;
- yellow flashing caution lights;
- 2 five gallon gasoline cans instead of 2 - one gallon cans; (one gallon cans do not provide adequate capacity for an uninterrupted survey);
- also, manuals outlining safety and inspection procedures need to be available at the inspection site and to state/local agency staff. This information could also be used by state/local staff for assisting in the preparation of the emissions survey.
- A paragraph should be added to describe how to properly moisten the PLUMBTESMO paper in such a manner as to obtain an accurate test result not enough water is as much a problem as too much water.

Item #2; In addition, discretion should be used when wiping out excessive tailpipe soot deposits. This practice should only be used when necessary, and not part of standard procedure - as now indicated.

- Please submit an updated inventory for the SO₂ emitting sources at your facility. Specifically, what are the SO₂ emissions from the heat plants (VAB Annex Plant and Central Plant). Include: design and permitted heat input; operation time; and permitted, potential and actual emissions.
- 2) Evaluate any increase or decrease of emissions (TPY) of any criteria pollutant due to the construction of the new SRB facility or to any modification within the last 5 years at your complex (KSC).
- 3) You may assume that the 25 million Btu/hr hot water generator No. 2 (at the VAB Annex Building), will be permitted and the allowable emissions will be 52.5 tons per year.

If the data shows the Kennedy Space Center is a major emitting facility for any criteria pollutant (> 250 tons per year) you will need to recommend a best available control technology (BACT) for your proposed project (SRBAF) for any pollutant whose emission increases above the significance level specified in the PSD regulations [(Table 500-2) Florida Administrative Code].

The Travertone fabrication process proposed by Armstrong World Industries, Inc. in their application dated October 15, 1984, will require a permit to construct from the Department. Construction of this source without a permit is a violation of the Department's regulations.

If a process recirculates air in a "closed loop" so that there is no discharge of air pollutants to the ambient air, then a Department permit is not required. However, a failure of the system that results in the emissions of air pollutants to the ambient air, even through other permitted air pollution control devices, could be a violation of the rules unless the permits to operate the other control devices authorize the additional air pollution source. In summary, a process can be built and operated as a "closed loop" system without a permit from the Department only if it is operated in a manner so that it does not have the potential to discharge air pollutants to the ambient air.

If Armstrong World Industries, Inc. proposes to discharge air pollutants from the Travertone fabrication process to the ambient air, they need to complete the application for permit for this source. If the information they submit gives reasonable assurance that the source can be built and operated in compliance with all local, state, and federal regulations, the Department will issue a permit to construct.

After that, Gardinier will have to schedule shutdowns of one mill at a time during lower production periods to replace the shells. This is a major undertaking and with proper debugging, this could easily take an additional two years. The dry rock mills will not be used unless some emergency occurs.

Because of this possibility, Gardinier would like to extend the permits until July 1, 1988. By that time, there should be no possibility of needing the dry mills.

INTENT TO ISSUE

The Department of Environmental Regulation hereby gives notice of its Intent to Issue, and proposed order of issuance for, a permit pursuant to Chapter 403, Florida Statutes, for the proposed project as detailed in the application specified above. The Department is issuing this Intent to Issue for the reasons stated in the attached Evaluation of the Request for a Permit to Construct an Air Pollution Source.

The applicant, United States Sugar Corporation, applied on January 10, 1984, to the Department of Environmental Regulation for a permit to construct a 545.5 million BTU/hr heat input bagasse/No. 6 residual oil fired boiler at their existing plant located near the intersection of W. C. Owens Avenue and Clewiston Street, Clewiston, Hendry County, Florida.

The Department has permitting jurisdiction under Chapter 403, Florida Statutes and Florida Administrative Code Rules 17-2 and 17-4. The project is not exempt from permitting procedures. The applicant was officially notified by the Department that an air construction permit was required for the proposed work.

This intent to issue shall be placed before the Secretary for final action unless an appropriate petition for a hearing pursuant to the provisions of Section 120.57, Florida Statutes, is filed within fourteen (14) days from receipt of this letter or

publication of the public notice (copy attached) required pursuant to Rule 17-103.150, Florida Administrative Code, whichever occurs first. The petition must comply with the requirements of Section 17-103.155 and Rule 28-5.201, Florida Administrative Code (copy attached) and be filed pursuant to Rule 17-103.155(1) in the Office of General Counsel of the Department of Environmental Regulation at 2600 Blair Stone Road, Tallahassee, Florida 32301.

Petitions which are not filed in accordance with the above provisions are subject to dismissal by the Department. In the event a formal hearing is conducted pursuant to Section 120.57(1), all parties shall have an opportunity to respond, to present evidence and argument on all issues involved, to conduct cross-examination of witness and submit rebuttal evidence, to submit proposed findings of facts and orders, to file exception to any order or hearing officer's recommended order, and to be represented by counsel. If an informal hearing is requested, the agency, in accordance with its rules of procedure, will provide affected persons or parties or their counsel an opportunity, at a convenient time and place, to present to the agency or hearing officer, written or oral evidence in opposition to the agency's action or refusal to act, or a written statement challenging the grounds upon which the agency has chosen to justify its action or inaction, pursuant to Section 120.57(2), Florida Statutes.

If a petition is filed, the administrative hearing process is designed to formulate agency action. Accordingly, the Department's final action may be different from the proposed agency action. In reference to your comment concerning the asbestos encapsulation project at the Air Route Traffic Control Center, as per Mr. Childers inspection report of August 30, 1984, I called U.S. Mineral Products Company, which manufactures Cafco Bond Seal, the sealant used at this site. I was advised by Mr. John Kloepping that U.S. Minerals does not advertise the use of this sealant to encapsulate asbestos containing materials. However, the company is quick to point out that this sealant was recommended as acceptable by Battelle (asbestos workshop manual, page 50). The company would not recommend any application procedure when used on asbestos containing materials.

I have asked EPA for some detailed guidance concerning sealants to encapsulate asbestos containing materials, and was advised such a program is underway. In the meantime, I will try to encourage removal instead of encapsulation.

DERM was the only program that did not reply to my inspection monthly update for the CDS report. I would appreciate it if you would return the October report as soon as possible.

- 1. Will the Hangar AF Small Parts Refurbishment Facility also be part of the new project or do you intend to build a facility for this purpose at the new location.
- 2. In figure A-l of Attachment A submitted with this application, the flow diagram shows VOC emission point (F) from Anodizing operations. The Alodine compound used in this process does not contain any VOC, as shown in Table A-l Oakite 214 M is the only compound used in small parts cleaning process, which contains VOC. How can the VOC emissions possibly occur from Anodizing operations when the Oakite-214 m (-) was used in the first step of small parts cleaning process?
- 3. In attachment B, "Emissions Estimates", the calculation shown in line 5 is questionable. It appears that density of Oakite considered in this calculation was (8.3 lb/gal X2) = 16.6 lb/gallon which is rather a fairly high density for a liquid cleaning agent. Table A-l shows water density as 8.4 lb/gal and therefore it seems that Oakite density should be 8.3 lb/gal if the table format is consistent. This certainly needs clarification because if there is an error, it will reflect a change in the emission rates.
- 4. What is the chemical composition and vapor pressure of the compounds used for the cleaning and chromatic conversion (table A-1)?

Compliance testing of loading tower No. 1 at our Jacksonville Bulk Terminal was conducted on September 15, 1984 in accordance with Specific Condition 10e of the above noted construction permit. The testing schedule was coordinated with the Jacksonville Department of Bio-environmental Services staff, various members of which inspected the facility prior to the test. None were able to be present during the test period.

Due to operational problems and high winds test results were inconclusive. Based upon this experience certain design improvements will be incorporated into the system. Completion of these improvements is anticipated during November, 1984. However, no additional rock shipments are scheduled during the coming months limiting further opportunities for testing. Therefore, an extension of the permit expiration date is hereby requested.

Further compliance tests will be conducted as soon as possible. However, to allow for uncertainties in ship scheduling we request that DER extend permit performance dates as follows:

- a) Test facility for compliance by 2/15/85.
- b) Submit operating permit applications by 3/15/85.
- c) Extend construction permit date to 6/15/85.

Your timely consideration of this request is appreciated.

The department is in receipt of your letter dated October 1, 1984, which was a response to the bureau's letter dated August 24, 1984. The bureau still finds the above referenced applications and supplementary material to be incomplete and the following information, including calculations, assumptions and reference documents, shall be submitted to the bureau before the status of your applications can, again, be ascertained:

- o Submit an entire facility inventory of all air polluting sources, including their potential pollutant emissions and quantifiable fugitive pollutant emissions in tons per year, each source's construction date, and each source's construction permit number and subsequent operating permit number(s).
- o If applicable, submit a PSD application with modeling, addressing all applicable requirements of FAC Rule 17-2.500.
- o If applicable, propose BACT (Best Available Control Technology) for all affected pollutants subject to new source review requirements as set forth in FAC Rule 17-2.500(2)(f). BACT determination shall be in accordance with FAC Rule 17-2.630.

o If applicable, propose LAER for VOC (volatile organic compounds) if the potential pollutant emissions exceed 100 tons per year total. If the facility is already emitting 100 TPY or more of VOC, then LAER determination would be required if emissions would increase by more than 40 TPY total. LAER determination shall be in accordance with FAC Rule 17-2.640.
