Hi, Jeff:

It is our understanding that SAPs "C" and "D" are already equipped with Cesium promoted catalyst technology. It is also our understanding that such technology can achieve emission limits between 1.5 and 2.5 lbs/ton of 100-percent H2SO4 for SO2. The preliminary determination, however, states that the current BACT limit for SO2 will remain unchanged at 3.5 lbs/ton of 100-percent H2SO4. We believe the preliminary determination needs to address the technical feasibility and/or the cost prohibitiveness of achieving the lower limits.
