The Department is in receipt of your January 20, 1987 request to amend DER permit no. A029-80046. The following changes are hereby made in the permit:

Specific Condition No. 1 -

FROM:

Test the baghouse for visible emissions at intervals of 12 months from the date of November 15, 1983 or within a ninety (90) day period prior to this date. The compliance test shall be conducted using EPA Method #9 (opacity). The Method #9 test interval on this source shall be thirty (30) minutes. Two copies of the test data shall be submitted to the Air Section of the Hillsborough County Environmental Protection Commission within forty-five days of testing.

TO:

Test the baghouse for visible emissions at intervals of 12 months from the date of November 15, 1983 or within a ninety (90) day period prior to this date. The compliance test shall be conducted using EPA Method #9 (opacity). The EPA Method #9 test interval on this source shall be thirty (30) minutes. of the test data shall be submitted to both the Environmental Protection Commission of Hillsborough County and the Florida Department of Environmental Regulation within forty-five days of such testing.

Specific Condition No. 6 -

FROM:

Submit for this facility, each calendar year, on or before March 1, an emission report for the preceding calendar year containing the following information as per Section 17-4.14, F.A.C.

- (A) Annual amount of materials and/or fuels utilized.
- (B) Annual emissions (note calculation basis).
- (C) Any changes in the information contained in the permit application.

This report shall be submitted in duplicate to the Environmental Protection Commission of Hillsborough County.

TO:

Submit for this facility, each calendar year, on or before March 1, an emission report for the preceding calendar year containing the following information as per Section 17-4.14, F.A.C.

- (A) Annual amount of materials and/or fuels utilized
- (B) Annual emissions (note calculation basis)
- (C) Any changes in the information contained in the permit application.

The emission report shall be submitted to both the Environmental Protection Commission of Hillsborough County and the Florida Department of Environmental Regulation.

Persons whose substantial interests are affected by this permit amendment have a right, pursuant to Section 120.57, Florida Statutes, to petition for an administrative determination (hearing) on it. The petition must conform to the requirements of Chapters 17-103 and 28-5.201, FAC, and must be filed (received) in the Department's Office of General Counsel, 2600 Blair Stone Road, Tallahassee Florida 32399, within fourteen (14) days of receipt of this notice. Failure to file a petition within the fourteen (14) days constitutes a waiver of any right such person has to an administrative determination (hearing) pursuant to Section 120.57, Florida Statutes. This permit is final and effective on the date filed with the Clerk of the Department unless a petition is filed in accordance with this paragraph or unless a request for extension of time in which to file a petition is filed within the time specified for

filing a petition and conforms to Rule 17-103.070, FAC. Upon timely filing of a petition or a request for an extension of time, this permit will not be effective until further Order of the Department.

When the Order (Permit) is final, any party to the Order has the right to seek judicial review of the Order pursuant to Section 120.68, Florida Statutes, by the filing of a Notice of Appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Department in the Office of General Counsel, 2600 Blair Stone Road, Tallahassee, Florida 32399; and by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The Notice of Appeal must be filed within 30 days from the date the Final Order is filed with the Clerk of the Department.
