Petitions must be filed within 14 (fourteen) days of publication of the public notice or within 14( fourteen) days of receipt of the notice of intent, whichever occurs first. A petitioner must mail a copy of the petition to the applicant at the address indicated above, at the time of filing. The failure of any person to file a petition within the applicable time period shall constitute a waiver to that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57 F.S., or to intervene in this proceeding, and participate as a party to it. Any subsequent intervention will be only at the approval of the presiding officer upon the filing of a motion in compliance with Rule 28-5.207 of the Florida Administrative Code. A petition must contain the following information:

(a) The name? address, and telephone number of each petitioner, the applicant's name and address, the Permit File Number, and the county in which the project is proposed,
(b) A statement of how and when each petitioner received notice of the permitting authority's action or proposed action,
(c) A statement of how each petitioner's substantial interests are affected by the permitting authority's action or proposed action,
(d) A statement of the material facts disputed by the petitioner, if

any, (e) A statement of the facts that the petitioner contends warrant a reversal or modification of the permitting authority's action or pro-

posed action;
(f) A statement identifying the rules or statutes that the petitioner contends require reversal or modification of the permitting authori-

contends require reversal or modification of the permitting authority's action or proposed action; and, (g) A statement of the relief sought by the petitioner, stating precisely the action that the petitioner wants the permitting authority to take with respect to the action or proposed action addressed in this petition.

Because the administrative hearing process is designed to formulate final agency action, the filing of a petition means that the permitting authority to take with respect to the action or proposed action addressed in this notice of intent.

In addition to the above, pursuant to 42 United States Code (U.S.C) Section 76614 (b) (2), any person may petition the Administrator of the EPA within 60 (sixty) days of the expiration of the Administrator of the FPA within 60 (sixty) days of the expiration of the Administrator's 45 (forty-five) day review period as established at 42 U.S.C. Section 7661 d(b) (1), to object to issuance of any permit. Any petition shall be based only on objections to the permit that were raised with reasonable specificity during the 30 (thirty) day per public comment period provided in this notice, unless the petitioner demonstrated to the Administrator of the EPA that it was impracticable to rise such objections within the comment period or unless the grounds for such objection arose after the comment period. Filing of a petition with the Administrator of the EPA does not stay the effective date of any permit properly issued pursuant to the provisions of Chapter 62-213, F.A.C. Petitions filed with the Administrator of EPA must meet the requirements of 42 U.S.C. Section 7661 d(b) (2) and must be filed with the Administrator of the EPA at 410 M. Street, SW, Washington DC 204660.
