
Respondent, State of Florida Department of Environmental Protection, has no objection to it. Therefore,




Dear Mr. Chisolm:

On behalf of Kissimmee Utility Authority (KUA), this letter serves to memorialize my conversation with you today during which I requested and you agreed to grant, a thirty (30) day extension of time under Rule 62-110.106(4), Fla Admin. Code, within which to petition for an administrative hearing pursuant to Sections 120.569 and 120.57, Fla Stat., challenging the Intent to Issue Draft Title V Air Operation Permit No. 0970043-002-AV, Facility I.D. No. 0970043, served by U.S. Mail to KUA on October 16, 1998.

During a telephone conference also of today's date, I informed Scott Sheplak, P.E., and Michael Halpin, P.E., of the Bureau of Air Regulation, of our intention to request the extension of time. Mr. Sheplak and Mr. Halpin authorized me to inform you that they had no objection to my request. Accordingly, it is my understanding that the Department has agreed to a thirty (30) day extension of time within which KUA may petition for a formal administrative hearing on the above-described Intent to Issue Title V Permit.
