Your Title V permit application for Reliant Energy Osceola, L.L.C. was received on April 1, 2002 and was found to be incomplete. In order to continue processing your application, the Department will need the below additional information pursuant to Rule 62-213.420(1)(b)2., F.A.C.

Application Scope

1. Is it the intent of Reliant Energy Osceola, L.L.C. to include the third combustion turbine in the Title V permit?
2. If no, the application is complete and no further information is required.
3. If yes, a compliance plan must be submitted. The plan must detail how and when compliance with the provisions of the permit to construct will be met for this emissions unit.

The Department must receive a response from you within 90 (ninety) days of receipt of this letter, unless you (the applicant) request additional time under Rule 62-213.420(1)(b)6., F.A.C.
