On behalf of Florida Power & Light Company (FPL) and its Designated Representative, Christian Kiernan, the West County Power Partners, LLC (WCPP), EPC Contractor for construction of the new combined cycle generating Unit 1 and 2 at the FPL West County Energy Center, is submitting the Fuel Oil Air Permit Compliance schedule in accordance with 40 CFR Part 60.8 and the State of Florida Conditions of Certification and Air Permit regulations. The updated test schedule is detailed in Table 1.
