If USEPA has an objection to the PROPOSED permit, the FINAL permit will not be issued until the permitting authority receives written notice that the objection is resolved or withdrawn.

An "INTENT TO ISSUE A TITLE V AIR OPERATION PERMIT RENEWAL" to Pasco County, for the Pasco County Resource Recovery Facility, located at 14230 Hays Road, Springhill, Pasco County, was clerked on November 28, 2006. The "PUBLIC NOTICE OF INTENT TO ISSUE A TITLE V AIR OPERATION PERMIT RENEWAL" was published in The Pasco Times on December 13, 2006.
