#### I. Public Notice.

An "INTENT TO ISSUE TITLE V AIR OPERATION PERMIT RENEWAL" to the Progress Energy Florida, Inc. for the for the P.L. Bartow Power Plant, located at 1601 Weedon Island Drive, St. Petersburg, Florida, Pinellas County, was clerked on September 29, 2004. The "PUBLIC NOTICE OF INTENT TO ISSUE TITLE V AIR OPERATION PERMIT RENEWAL" was published in the St. Petersburg Times on Wednesday October 6, 2004. The DRAFT Title V Air Operation Permit Renewal was available for public inspection at the Department's Southwest District office in Tampa and the permitting authority's office in Tallahassee. Proof of publication of the "PUBLIC NOTICE OF INTENT TO ISSUE TITLE V AIR OPERATION PERMIT RENEWAL" was received on October 8, 2004.

#### II. Public Comment(s).

No comments were received from the citizens, environmental groups, municipalities or other agencies.

#### III. Applicant's Comments

An extension of time to file a petition for an administrative proceeding was filed by the applicant on October 13, 2004. The Department granted the extension of time until November 1, 2004. A second request for extension of time to file a petition for an administrative proceeding was filed by the applicant on November 1, 2004. Once an agreement is reached on the Proposed Permit, the applicant will withdraw the extension request.

Comments were received from the applicant by electronic mail on November 1, 2004 and confirmed by a letter received on November 4, 2004. Additional comments were submitted via a facsimile on November 8, 2004. Comments were very minor. The comments in general were considered not significant enough to require the issuance of a revised DRAFT permit. The key requests are as follows:

#### Section III, Subsection A.22, B.15, C.12 and D.11

Progress Energy Florida would like to include "ASTM D1552-95 or equivalent method" to the list of test methods for determining fuel sulfur content.

The applicant would like to add "B.19" under the permit condition column for EU(-004) Bartow-Anclote Pipeline Heating Boiler. This condition excludes VE's if the boiler runs solely on gas.

#### IV. Department Response:

The Department agrees with the applicant's requested changes to conditions A. 22, B.15, C.12 and D.11 by requiring that the equivalent method should be approved by the Department prior to its use. Therefore, the language for conditions A.22, B.15, C.12 and D.11 should read as follows:

- A.22. The fuel sulfur content, percent by weight, for liquid fuels shall be evaluated using either ASTM D2622-92, ASTM D4294-90, both ASTM D4057-88 and ASTM D129-91, or the latest edition, or ASTM D1552-95 or an equivalent method after Department approval. [Rules 62-213.440, 62-296.405(1)(e)3., 62-296.405(1)(f)1.b. and 62-297.440, F.A.C.]
- **B.15.** The fuel sulfur content, percent by weight, for liquid fuels shall be evaluated using either ASTM D2622-92, ASTM D4294-90, both ASTM D4057-88 and ASTM D129-91, or the latest edition, or ASTM D1552-95 or an equivalent method after Department approval. [Rules 62-213.440 and 62-297.440, F.A.C.]
- C.12. The fuel sulfur content, percent by weight, for liquid fuels shall be evaluated using either ASTM D2622-92, ASTM D4294-90, both ASTM D4057-88 and ASTM D129-91, or latest edition, or ASTM D1552-95 or an equivalent method after Department approval. [Rules 62-213.440 and 62-297.440, F.A.C.]
- **D.11.** The fuel sulfur content, percent by weight, for liquid fuels shall be evaluated using either ASTM D2622-94, ASTM D4294-90, both ASTM D4057-88 and ASTM D129-95, or the latest edition(s), or ASTM D1552-95 or an equivalent method after Department approval. [Rules 62-213.440 and 62-297.440, F.A.C.]

The Department concurs with the requested changes to Appendix I-1 and Appendix U-1 and will replace these tables.

The Department will also make the necessary changes as requested for Table 2-1, Summary of Compliance Requirements. The Administrative Order RTF No. 96-A-01 signed on February 10, 1997 allows the frequency of testing for EU(-001) from 6 months to annual for VE and PM. Additionally, Condition "B.19" will be added in the summary table for EU(-004) as requested by the applicant.

#### V. Conclusion.

The permitting authority hereby issues PROPOSED Permit Renewal No. 1030011-009-AV, with the changes noted above.
