Dear Mr. Reynolds:

This is a request to reissue this construction pending the re-evaluation of the BACT for this project. Enclosed is a check in the amount of \$250 to cover the permitting fee for this action as A. A. Linero advised. This permit was originally issued June 10, 1993 and expired on January 31, 1994. The expiration date was then extended until July 31, 1995. The project was postponed at the time due to unfavorable economic conditions. At the present time, conditions are more favorable for implementation of the project.

At the time of review of this project, a comment was received from J. A. Harper, USEPA, suggesting outlet grain loadings for the dry food processing industry would be applicable to this project. It should be pointed out that this project deals with mineral feed ingredients to be added to feed materials. The mineral products have a higher density than food grains and if this were accounted for, the required grain loading was more than stringent.
