By letter dated August 14, 2006 and received by Tampa Electric Company on August 21, 2006 via mail, the Florida Department of Environmental Protection (FDEP) announced its intent to issue an air construction permit for the referenced project at the Polk Power Station located in Polk County, Florida. Tampa Electric Company has had an opportunity to review the intent to issue the construction permit along with the proposed conditions and are currently working with FDEP to resolve certain issues with the conditions of this proposed permit.
