Project: This project authorizes the replacement of the existing baghouse system located in the Converting Department with a new drum filtering system will control emissions of particulate matter from 12 converting lines in the Converting lines in the Converting Department. Based on the expected emissions, the new drum filtering system will reduce emissions from the 12 converting lines. Therefore, the project will not trigger preconstruction review for the Prevention of Significant Deterioration (PSD) of Air Quality pursuant to Rule 62-212-400, Florida Administrative Code (F.A.C.).

Notice of Intent to Issue Air Permit: The Permitting Authority gives notice of its intent to Issue an air construction permit to the applicant for the project described above. The applicant has provided reasonable assurance that operation of proposed equipment will not adversely impact air quality and that the project will comply with all appropriate provisions of Chapters 62-4, 62-204, 62-210, 62-212, 62-296 and 62-297, F.A.C. The Permitting Authority will issue a final permit in accordance with the conditions of the proposed draft permit unless a timely petition for an administrative hearing is filled under Sections 120.569 and 120.57, F.S. or unless public comment received in accordance with this notice results in a different change of terms or conditions.

comments: The Permitting Authority will accept written comments concerning the proposed draft permit for a period of 14 days from the date of publication of the Public Notice. Written comments must be received by the Permitting Authority by close of business (5:00 p.m.) on or before the end of this 14-day period. If written comments received result in a significant change to the draft permit, the Permitting Authority shall revise the draft permit and require, if applicable, another Public Notice. All comments filed will be made available for public inspection.

Petitions: A person whose substantial interests are affected by the proposed permitting decision may petition for an administrative hearing in accordance with Sections 120.569 and 120.57, F.S. Petitions filed by the applicant or any of the parties listed below must be filed within 14 days of receipt of this written notice of interest of the received within 14 days of receipt of this written notice under Section 120.60(3), F.S., must be filed within 14 days of publication of the attached Public Notice or within 14 days of receipt of this written notice of intent to issue Air Permit, whichever occurs first. Under Section 120.60(3), F.S., however, any person who asked the Permitting Authority for notice of agency action may file a petition within 14 days of receipt of that notice, regardless of the date of publication. A petitioner shall mall a copy of the perition to the applicant at the address indicated above, at the time of filling. The fallure of any person to file a petition within the appropriate time period shall constitute a walver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57, F.S., or to intervene in this proceeding initiated by an other party) will be only at the approval of the presiding officer upon the filling of a motion in compliance with Rule 28-106.205, F.A.C.

Because the administrative hearing process is designed to formulate final agency action, the filling of a petition means that the Permitting Authority's final action may be different from the position taken by it in this Public Notice of intent to issue Air Permit. Persons whose substantial interests will be affected by any such final decision of the Permitting Authority on the application have the right to petition to become a party to the proceeding, in accordance with the requirements set forth above.
