Dear Mr. Shellhouse:

On November 26, 2008, we received your application and sufficient fee for an air construction permit to add a new emergency generator at Taylor County Compressor Station No. 15. The facility is located in Taylor County at 2065 Pisgah Road, CR361 in Perry, Florida. The application is incomplete. In order to continue processing your application, please provide the additional information requested below. Should your response to any of the requested items require new calculations, please submit the new calculations, assumptions, reference material and appropriate revised pages of the application form.

1. For each existing and proposed emergency generator please provide the identification number, horsepower rating, fuel type, and hourly fuel consumption rate of each unit in million standard cubic feet of natural gas, or gallons of gasoline or gallons of diesel fuel.
2. You state that engines in compliance with 40 CFR 60 Subpart JJJJ are considered to be in compliance with 40 CFR 63 Subpart ZZZZ. For these particular units and expected hours of operation please identify the applicable requirements of 40 CFR 60 Subpart JJJJ and 40 CFR 63 Subpart ZZZZ.


The above information is requested pursuant to the following F.A.C. regulations: Rule 62-4.050 (Procedures to Obtain Permits and Other Authorizations; Applications); 62-4.055 (Permit Processing); 62-4.070 (Standards for Issuing or Denying Permits; Issuance; Denial); 62-4.120 (Construction Permits); 62-204.800 (Federal Regulations Adopted by Reference); 62-212.300 (Permits Required); 62-210.370 (Emissions Computations and Reporting); 62-210.900 (Forms and Instructions); 62-212.300 (General Preconstruction review); and 62-212.400 (Preventions of Significant Deterioration). All applications for a Department permit must be certified by a professional engineer registered in the State of Florida pursuant to Rule 62-4.050(3), F.A.C. This requirement also applies to responses to Department requests for additional information of an engineering nature. For any material changes to the application, please include a new certification statement by the authorized representative or responsible official.

We will resume processing your application after receipt of the requested information. You are reminded that Rule 62-4.055(1), F.A.C. requires applicants to respond to requests for information within 90 days or to provide a written request for an additional period of time to submit the information.
