Dear Mr. Anderson:

On May 19, 2009 the Department received your application for a Title V renewal permit for the DeBary Power Plant. The application is incomplete. In order to continue processing your application, the Department will need the additional information requested below pursuant to Rule 62-213.420(1)(b)3., Florida Administrative Code (F.A.C.), and Rule 62-4.070(1), F.A.C. Should your response to any of the items below require new calculations, please submit the new calculations, assumptions, reference material and appropriate revised pages of the application form.

- 1. Attachment E List of Insignificant Activities appears to contain a copy and paste of Rule 62-210.300(3)(a), F.A.C. Please provide a concise list of the specific units/activities at the DeBary facility that qualify as insignificant units pursuant to Rule 62-213.430(6), F.A.C.
- 2. If the units/activities in question do not meet the requirements of Rule 62-213.430(6), F.A.C., they could possibly be listed as unregulated emissions units, as long as no unit specific applicable requirements apply. Please provide a list of those units/activities that do not have unit specific applicable requirements, but have the potential to emit air pollution at levels greater than specified in Rule 62-213.430(6), F.A.C.
- 3. Please specify if any of the facility's generators or other internal combustion engines are subject to 40 CFR 60 Subpart IIII, Standards of Performance for Stationary Compression Ignition (CI) Internal Combustion Engines (ICE), 40 CFR 63 Subpart ZZZZ, National Emission Standards for Hazardous Air Pollutants for Stationary Reciprocating Internal Combustion Engines, or 40 CFR 60 Subpart JJJJ, Standards of Performance for Stationary Spark Ignition (SI) Internal Combustion Engines. If applicable,
 - a. Please specify how the facility is complying with the applicable subpart(s).
 - b. Please provide the following information for each emission unit subject to the referenced subparts: inservice date, cylinder displacement, and rule applicability.
- 4. The Acid Rain Part Application submitted with the application was submitted using the old version of DEP Form No. 62-210.900(1)(a), effective 06/16/03. The current version of DEP Form No. 62-210.900(1)(a), effective 3/16/08 should be used. Please re-submit the Acid Rain Part Application using the current form.

In order to ensure that your acid rain permit is effective by January 1, 2010, you are highly encouraged to respond to this request as soon as possible.
