REQUEST FOR EXTENSION OF TIME

By and through undersigned counsel, City of Gainesville, Gainesville Regional Utilities (GRU) hereby requests, pursuant to Florida Administrative Code Rules 28-106.111(3) and 62-103.050(1), an extension of time to and including November 14, 1997, in which to file a Petition for Administrative Proceedings in the above-styled matter. As good cause for granting this request, GRU states the following:

1. On or about August 27, 1997, GRU received from the Department of Environmental Protection (Department) an "Intent to Issue Title V Air Operation Permit" (Permit No. 0010005-001-AV) for the J.R. Kelly Generating Station in Alachua County, Florida. Along with the Intent to Issue, GRU received a draft Title V permit and "Public Notice of Intent to Issue Title V Air Operation Permit."

2. By Order dated October 21, 1997, the Department granted GRU an extension until October 31, 1997, to file a Petition for Administrative Proceedings. GRU requested an additional extension until November 7, 1997. While an order granting this request has not yet been issued, representatives from the Department orally agreed to the extension until November 7, 1997.

3. The draft permit and associated documents contain several provisions that warrant clarification or correction.

4. GRU has corresponded and will continue to correspond with Department representatives from the Division of Air Resources Management in an effort to resolve its concerns regarding the draft permit.


5. This request is filed simply as a protective measure to avoid waiver of GRU's right to challenge certain conditions contained in the draft Title V permit. Grant of this request will not prejudice either party, but will further their mutual interest and likely avoid the need to file a petition and proceed to a formal administrative hearing.

6. Lennon Anderson with the Bureau of Air Regulation has agreed to an extension until November 14, 1997 on behalf of the Department. Counsel for GRU has also contacted Jeffrey Brown with the Office of General Counsel regarding this request, and he has no objection.

WHEREFORE, GRU respectfully requests that the time for filing of a Petition for Administrative Proceedings in regard to the Department's Intent to Issue Title V Air Operation Permit for Permit No. 0010005-001-AV be formally extended to and including November 14, 1997.
