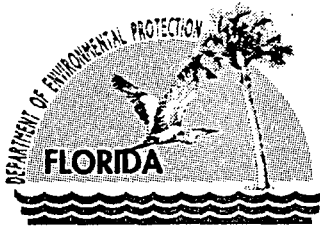



Dear Mr. Santella:

In our letters to you dated August 22, 2000, and August 17, 2001, we indicated certain incompleteness items needed to process your request for a minor modification to the referenced facility PSD permit for the construction of two minor source wet scrubbers. However, to date, we have not received a written response. We cautioned in our letters that Rule 62-4.055(1), F.A.C., requires a response to requests for information within 90 days.

If you wish to further pursue this permitting action, please provide the needed information within 30 days of receipt of this letter. Alternately, you could formally withdraw the application, thus avoiding the need for us to *deny the request for the modification to the permit*.
