On December 29, 2010, the Department received your fuel additive test report required by air construction permit number 0250003-008-AC, specific conditions 3 and 13. The Department requested additional testing information which you provided on January 19, 2011. The report requirements of specific conditions 3 and 13 have been met and the report is deemed complete.

However, the permit also requires new state-of-the-art multi-cyclones be installed at units 001 and 002 before December 31, 2013. After installation and subsequent testing of the new multi-cyclones, the particulate emission limits indicated in specific condition 13 will be revisited at that time.
