Dear Mr. Elder:

We have reviewed your response dated September 8, 1997, to the Department's request for additional information dated April 28, 1997. The Department has noted that you are withdrawing your request to use wastewater treatment sludge as a fuel, but would pursue firing wood waste and yard waste. Based on our review, we have determined that additional information is needed in order to continue processing this request of firing other carbonaceous fuels such as wood waste and yard waste in the No. 10 Coal/Bark Boiler. Please submit the information requested below to the Department's Bureau of Air Regulation:

- As indicated in the response, the maximum wood and yard waste fuel input will be limited to 4,600 lb/hr (difference of carbonaceous and bark fuel input). This input rate is greater than the threshold indicated in 40 CFR 60 Subpart Eb Section 60.50b(b). Please explain why that section will not apply to this facility. If Subpart Eb does apply to the facility, what measures will be taken to comply with the requirements of the subpart?

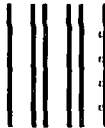
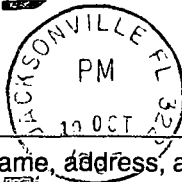
