Generic Emissions Unit Exemption

On July 28, 2008, and subsequent dates, we received information to support JEA's contention that the usage of fuel additives in the existing JEA Northside Generating Station's CFB Boilers Nos. 1 and 2 (boilers) will assist in the reliable operation of the boilers by preventing agglomeration of the bed material while firing 100 percent petroleum coke, which would require the boilers to be shutdown for maintenance. The information and supplementary information was submitted to support the JEA's contention that the receiving, storage, reclamation and usage of the fuel additive material would qualify for a generic emissions unit exemption pursuant to Rule 62-210.300(3)(b)1., Florida Administrative Code. Based on information received and reviewed during the evaluation process, JEA's position appears to be valid and should be recognized in the Title V Air Operation Permit as an insignificant activity and as a fuel additive under the Methods of Operation in the emissions units' subsection. We recommend your approval of the attached Receipt of Notification of Generic Emissions Unit Exemption letter.


