NOTICE OF WITHDRAWAL OF EXTENSION OF TIME

The Jacksonville Electric Authority (JEA), by and through undersigned counsel, hereby withdraws its Request for Extension of Time to file a petition for formal administrative proceedings in accordance with Chapter 120, Florida Statutes in the above-referenced matter. JEA filed its last Request for Extension of Time until December 31, 1998, in response to the "Intent to Issue Title V Air Operation Permit" (Revised Permit No. 0310045-002-AV) for the JEA Northside Generation Station/St. Johns River Power Park facility located in Duval County, Florida, to negotiate certain changes in the draft Title V permit revision with the Department of Environmental Protection (Department). Based on discussions with Department representatives, JEA and the Department have come to an agreement on the issues involved in the above-referenced draft Title V permit revision. The agreement between JEA and the Department is reflected in the draft Title V permit revision and a Department Memorandum to the File dated November 13, 1998, copies of which are attached to this Notice. Therefore, JEA hereby withdraws its Request for Extension, conditioned upon the Department's issuance of the Proposed Permit in accordance with the Department's agreement with JEA.


